No one signed up for public speaking.

There was a moment of silence for the passing of Jennifer Duran, mother of LISD students.

April Martinez made the motion to approve the Budget Training minutes of July 17, 2023 and the Regular Board minutes of July 20, 2023. Ernest Ogeda seconded it. It passed by a vote of 5-0.

CFO Ron McBee gave a brief report of the finances. April Martinez made the motion to approve the Financial Report. Kevin Telchik seconded it. It passed by a vote of 5-0.

Coach Vanessa Hernandez introduced the 2022-2023 Softball Team-Aliyah Morales, Laila Vasquez, Amaya Vasquez, Emily Capetillo, Melanie Benitez, Kaylee Hernandez, Kayleigh Sanchez, Zoey Sifuentes and Coaches Jeremy Hernandez and Elisa Benitez. All Board members present and Superintendent Ritchey thanked the team for representing Lamesa ISD well and congratulated them on their accomplishments.

All Principals present gave a brief report of their respective campuses. Doug Tipton is the Principal for South Elementary, Kristi Griffin is the Principal for North Elementary, Melanie Jasper is the Principal for Middle School and Israel Carrera is the Principal for High School.

Mr. Ritchey introduced Cris Norris, the Insurance representative for Lamesa ISD. Norris presented the renewal of the Interlocal Agreement with Property Casualty Alliance of Texas (PCAT) and the Property, Casualty and Automobile Insurance and the Worker's Compensation Insurance. The Board was in agreement with the renewal as presented.

Ernest Ogeda made the motion to approve a partnership with Proximity Learning Inc. to provide virtual instruction for two courses at Lamesa High School for 2023-2024 school year. April Martinez seconded it. It passed by a vote of 5-0.

Kevin Telchik made the motion to approve the 2023-2024 Compensation Plan and Supplemental Pay recommendation. Ernest Ogeda seconded it. It passed by a vote of 5-0.

Ernest Ogeda made the motion to accept the bid of property located at 805 NE 4th Street. April Martinez seconded it. It passed by a vote of 5-0.

The Board did not go to Closed Session.
