During the time of expulsion, the student shall not be on school grounds or attend any functions at Reeths-Puffer Schools unless approved in advance by the Superintendent of Schools. The motion passed unanimously.

It was moved by Alex Keefe and supported by Joan Vincent to accept the recommendation of administration that the student identified as Student DW23-24-2, be expelled for up to 180 school days from Reeths-Puffer Schools for the reason that she has failed to follow the rules and regulations contained in the Student Code of Conduct resulting in a disruption of the education process for both student DW2324-2 and others and such behavior is sufficient to warrant expulsion pursuant to Section 1311(2) of the Michigan School Code. During the time of expulsion, the student shall not be on school grounds or attend any functions at Reeths-Puffer Schools unless approved in advance by the Superintendent of Schools.

It was moved by Jennifer Romanosky and supported by Chris Brooks to accept the recommendation of administration that the student identified as Student EH23-24-1, be expelled, permanently, subject to possible reinstatement after 180 school days from Reeths-Puffer Schools for the reason that he has failed to follow the rules and regulations contained in the Student Code of Conduct resulting in a disruption of the

education process for both student EH2324-1 and others and such behavior is sufficient to warrant expulsion pursuant to Section 1311 (2) of the Michigan School Code. During the time of expulsion, the student shall not be on school grounds or attend any functions at Reeths-Puffer Schools unless approved in advance by the Superintendent of Schools.

It was moved by Susan Blackburn and supported by Chris Brooks to adjourn the meeting. The meeting adjourned at 6:55 p.m.
