SCHOOL BOARD MEETING MINUTES

Tuesday, September 26, 2023

I. ROLL CALL & CALL TO ORDER

A regular meeting of the Fairmont Area Schools Board of Education was held on Tuesday, September 26, 2023 at 5:15 p.m. in the Wm. Budd Board Room. Members in attendance were Nicole Green, Mike Edman, Julie Laue, Dan Brookens, Mari Myren, and Jen Harris.

A motion was offered by Mike Edman, seconded by Mari Myren and carried to unanimously approve the September 12, 2023 school board meeting minutes.

VII. FINANCIAL BUSINESS

A. **Donation**

A resolution was offered by Dan Brookens, seconded by Julie Laue, and adopted on a unanimous roll call vote to accept the donation of a tennis ball machine and tennis cart from Emily Weisser. The donation is valued at \$3,200.

B. Financial Reports & Bills

Director of Finance and Business Management, Jessica Korte, reviewed this month's financial reports.

A. Proposed 2023 Payable 2024 Tax Levy

Director of Finance and Business Management, Jessica Korte, presented the levy and explained that the formula used by the State of Minnesota provides annual adjustments based on student enrollment. This year's calculation will result in an increase of approximately 2.74%, generating approximately \$172,000 of additional revenue. Board member Mike Edman reminded the public that the school district levy differs from that of the City. The City is allowed to set its budget and then levy for the amount of dollars needed. School district levy amounts are set by the state, and school districts must then plan their budget around that dollar amount.

A motion was offered by Julie Laue, seconded by Jen Harris, and carried to unanimously approve the Proposed 2023 Payable 2024 Tax Levy to the maximum amount available.

B. Truth in Taxation Hearing

D. Student Participation Fees

A motion was offered by Dan Brookens, seconded by Mike Edman, and carried to unanimously approve the 2023-2024 student participation fees.
