Dear Parents,

I hope this finds you all doing well and your child is having a successful school year at Unit 20. Here in the Special Services office we strive to provide our students with the best services and support possible. As part of this, the Illinois State Board of Education's (ISBE) Special Education Department collaborates with Measurement Inc, a contracted company, to conduct a parent survey periodically. The purpose is to see how well we are doing at involving parents of students Individualized Education Programs in their child's education. Those results are then shared with the District and are used as a tool for improvement. These results are very important to both ISBE and Unit 20's Special Services Department.

In January, ISBE began to send out these surveys via mail with a submission date of May 15th. You are/were able to complete the surveys either online or by mail. However, to date we've only received 6 completed surveys as reported to us by ISBE. We are asking for parents to please look for your survey letter and complete the survey as soon as possible. The deadline is May 15th, 2024.

Your opinions are very important to us. Your answers will be combined with those from other parents to help the state and individual school districts improve family-school partnerships in special education. No one from your school district will know how you answered the survey questions.
