BAS 2023-2024 COVID-19 Response Plan has been a collaborative effort of the district administrators and staff to inform students, parents and district personnel on planning for the upcoming school year. It should be noted that this plan is a working document and likely to change as more relevant or pertinent information becomes available (data) or new strategies for addressing COVID-19 in public education. Throughout the summer and school year BAS receives updates and input from the Western UP Health Department, Upper Peninsula Health System, Copper Country ISD and neighboring districts in analyzing data, formulating strategies, and adapting protocols and procedures to best meet the safety and educational needs of all our students. The BAS COVID-19 Preparedness and Response plan is a working document and changes and information are to be reviewed as needed as part of the BAS Board of Education's regularly scheduled meetings. BAS will adhere to all CDC, MDHHS and/or MCHD orders regarding COVID-19 as they pertain to public schools in Michigan. If such an order is rescinded, BAS will default to our previous guidelines if feasible.

Online Learning As currently constructed, BAS will adhere to the following guidelines for online learning:

• Online classes will not be offered as an option to all students in grades K-12. If enough students opt for a specific class in a specific grade level, a certified BAS teacher may be assigned as a virtual instructor

- If circumstances necessitate a classroom, building or district wide move to online learning, preK-12 students enrolled in online classes will continue in that format. All other students will receive virtual instruction from their regularly assigned teachers
- BAS will provide a rigorous and robust distance-learning program for any student affected in grades preK-12. BAS will be issuing credit and grade advancement for satisfactory completion of courses over the time of closure. Teachers will track student participation; monitor student wellness; grade assignments, homework and quizzes; provide feedback on student work; differentiate instruction; communicate through zoom, google meets, email, and google classroom.
- Students with IEP's, 504's and other learning plans will be provided accommodations that fit their learning needs at all times. Ancillary services will be provided to the extent staff is limited by local, state or CDC guidelines. Services such as OT, PT and speech may happen virtually if appropriate.

Safety Protocols Personal Protective Equipment (PPE)/Facial Coverings Requirements:

• Effective February 25, 2022, CDC does not require wearing of masks on buses or vans operated by public or private school systems, including early care and education/child care programs.

District and Building Implementation Plan:

- BAS may be required to transition to this plan on very short notice.
- Face coverings may be ordered and available to every student and staff member on a daily basis. The supply of masks located on buses and in the classrooms will be monitored by staff.

• Clear face coverings may be provided to all teachers with the option to wear the clear mask during instruction.

Hygiene Recommendations:

- Adequate supplies of soap, hand sanitizer with at least 60% alcohol, paper towels, tissues, and signs reinforcing proper handwashing techniques will be provided to support healthy hygiene behaviors
- Staff will teach and reinforce handwashing with soap and water for at least 20 seconds and/or the safe use of hand sanitizer that contains at least 60% alcohol.
- Staff and students will cough and sneeze into their elbows or cover with a tissue. Used tissues should be thrown in the trash and hands washed immediately using proper hand hygiene techniques.
- Soap and hand sanitizers will be systematically and frequently checked and refilled.

District and Building Implementation Plan:

- Every classroom will be supplied with hand sanitizer, wipes, etc. All classroom and office entrances are equipped with a hand sanitizer station.
- Supplies (paper towels, hand sanitizer, tissues, trash receptacles) will be checked daily and restocked in the classroom.
- Teachers will contact the office if supplies run low during the school day.

Screening Students and Staff Recommendations:

- All students and staff should self-screen before coming to work or school. If students/staff are displaying systems of COVID-19 they should stay home and monitor for 24 hours. Currently, BAS will not temperature check or screen students before entry each day.
- Staff should conduct daily self-examinations, including a temperature check, prior to coming to work. If they exhibit principal symptoms of COVID-19 or have a temperature of 100.4 or greater, they should stay home.

• Symptomatic students and staff sent home from school should be kept home.

Food Service Recommendations:

• Students, teachers, and food service staff should wash hands before and after every meal.

Athletics/ Extra Curricular Recommendations:

- Spectators are currently allowed at events and the district will follow the safety guidance established by the MHSAA.
- Indoor concession will be allowed with consideration to CDC, MCHD and MDHHS guidelines for providing food and drink inside school facilities.
