All professionals with at lesat 20 years of experience will be paid an additional \$600 supplement which IS NOT included in the salary schedule.

Vocational agriculture teachers shall be paid a stipend of \$600 which shall be prorated based upon the percentage of time spent teaching vocational agriculture classes.

Classroom teachers with National Board for Professional Teaching Standards certification shall be paid an annual bonus of \$3,500 plus an annual bonus of \$3,500 from levy funds for the life of the certificate, not to exceed ten years for any one license. Classroom teachers with NBPTS certification who are employed at a school designated as a persistently low performing school and who serve in a mentoring capacity for other teachers at the school shall be paid an additional \$2,000 supplement.

WVDE-designated speech language pathologists, audiologists, counselors, school psychologists and school nurses with national certification shall be paid an annual bonus of \$2,500 plus an annual bonus of \$2,500 from levy funds for the life of the certificate, not to exceed ten years for any one license.

Each classroom teacher providing math instruction in the teacher's certified area of study for at least 60 percent of the time the teacher is providing instruction to students shall be considered to have three additional years of experience only for the purposes of the salary schedule set forth in subsection (b) of 18A-4-2.

Each classroom teacher certified in special education and employed as a full-time special education teacher shall be considered to have three additional years of experience only for the purposes of the salary schedule set forth in subsection (b) of 18A-4-2.

Classroom teachers required to cover a class or provide student supervision during their planning period due to the unavailability of a substitute teacher or as approved in advance by the superintendent shall be paid \$30 per occurrence.

Teachers of the visually impaired who are certified in orientation and mobility services and are providing such services to students shall be paid an annual supplement of \$5,000.
