AGREEMENT TO PARTICIPATE FORM

Due to the risk of injury involved, I recognize the importance of following coaches' instructions regarding, but not limited to playing and practicing techniques, training and team rules, and to obey such instructions. By signing a statement, you, as the player, acknowledge that you read it, understood it, and agree to follow the rules and regulations of your coach and of the **Seneca East Baseball Club**. Additionally, your signature affirms that you are in good physical health and know of no condition or reason that you should not participate.
