The SAU #7 School Boards are seeking a superintendent as they work from their belief that it is essential for any community to have a well-educated and well-informed citizenry. In order to have such a community, educating children is of critical importance. In the process of educating, there must be an expectation of excellence coming from the top-down, as well as from the bottom-up. Our search for a superintendent focuses on bringing that expectation into our schools. A strong superintendent will benefit all the communities.

The Superintendent shall serve as the executive officer of the school districts, be responsible for the overall administrative and leadership services of the SAU, and perform the duties specified in the NH Administrative Rules Ed 302.01 and 302.02, including planning and managing the administrative and leadership services in the district within statutory requirements, state administrative rules, and districts' policies.

SAU #7 is governed by 5 elected school boards (Clarksville (3), Colebrook(7), Columbia (3), Pittsburg (5), and Stewartstown(3) with an overarching Executive board.

School Administrative Unit (SAU #7) comprises five towns in the northern area of New Hampshire north of the White Mountains. The schools served by SAU #7 are (Clarksville, Colebrook, Columbia, Stewartstown & Pittsburg) with a total population of 4650 that has 3,071 registered voters. Our towns enjoy proximity to the White Mountains, Canada, Northern Vermont, and Maine. This area provides numerous four season outdoor adventure opportunities such as hiking in the beautiful White Mountains, fly fishing the streams, kayaking and boating the natural lakes and ponds, horseback riding and cross-country skiing the many miles of groomed trails, hunting in all the many acres offered by the White Mountain National Forest, and alpine skiing on premier slopes of the Northeast. A major draw to the area are its miles and miles of snowmobile trails and ATV trails that bring outdoor enthusiasts to the area year round. Many local events such as Hunt of a Lifetime, Area Moose Festival Weekend, Pittsburg Old Home Day, and renowned Fourth of July celebrations bring the communities together.
