If there are more applicants than openings, a lottery system will be used to select students. Children selected for the program are not guaranteed placement for subsequent school years and must re-apply. If a lottery is needed, parents will be invited to attend the lottery drawing which will take place on Tuesday, March 19, 2024 at 3:20 p.m. at JFK/AFM Library at 200 Lincoln St. Blackstone. You will be notified of the lottery results by March 22, 2024. If a lottery is necessary and your child is selected, you will need to reserve your slot by submitting your first non-refundable installment by May 5, 2024 which will be applied to the first month's tuition (September 2024). <u>Tuition</u>: Tuition fees are as follows based on ½ days: \$140/month for 2 days a week; \$210/month for 3 days a week; \$280/month for 4 days a week or \$350/month for 5 days a week.
