

**TERRANCE A. AND IRMA L. FRIEDMAN
AND
CHARLES H. SKUZA SCHOLARSHIP PROGRAM**

In honor of TERRANCE A. & IRMA L. FRIEDMAN and CHARLES H. SKUZA for their contributions to what is now known as Vibracoustic North America, the Charles H. Skuza Scholarship was renamed the Terrance A. and Irma L. Friedman and Charles H. Skuza Scholarship Program. Mr. Friedman laid the foundation many, many years ago for what is now known as Vibracoustic North America. This scholarship was established in the 1994-95 school year by Trelleborg Automotive USA, Inc. for the purpose of providing resources to allow qualified students to continue their education at a college or university. The scholarship provides a method to return something to the Carmi community and the employees of our company for the years of support to what is now known as Vibracoustic since its original beginning in South Haven in 1955.

A scholarship in the amount of a \$2,500 will be awarded to a qualified graduating high school senior. To receive this award the student must achieve certain academic standards, meet other requirements in areas of leadership, community service, exhibit clearly defined goals for a college education and outline his/her financial need.

Scholarship Application Information

Eligibility

- A. High School Senior
- B. Candidates must meet all selection criteria and rank in the top 50% of his/her class
- C. Qualified candidates will be chosen subject to the following order of priority:
 - a. Child of VIBRACOUSTIC employee or employee's spouse, based on medical insurance eligibility guidelines.
 - b. If there is no student that meets the criteria listed above in "a" then Human Resources will open the application process up to students graduating from a White County High School

Additional Selection Criteria

Must Have:

- A. A cumulative grade point average of 3.0 or higher on a 4.0 scale
- B. Demonstrated leadership capabilities in school and community
- C. Performed service to school and community
- D. Clearly defined goals and objectives for a college education
- E. Financial need
- F. Been accepted to a two or four year college or university

Additional Information

- A. This scholarship totals \$2,500 per school year to cover tuition, books, and on-campus room & board in facilities managed by the college or university.
- B. Renewable for 1 additional school year for a two year school or 3 additional school years for a four year school, if recipient maintains at least a 3.0 cumulative grade point average.
- C. Awarded annually through the recipient's school at the Spring awards assembly.
- D. Payable to the business office of the recipient's college or university.
- E. Must submit proof of maintenance of a 3.0 cumulative grade point average to VIBRACOUSTIC each term.
- F. Changes in facts or circumstances from those presented on the original scholarship application may disqualify the recipient.

REQUIRED Information to be submitted in order to be consider for scholarship (Not providing a complete packet (A-D Below) will disqualify candidate from consideration)

- A. Completed scholarship application
- B. High school transcripts
- C. Acceptance letter from college or university
- D. A copy of the Expected Family Contribution (EFC) page from Free Application for Federal Student Aid. This verifies the financial need of applicant.
