GENERAL

- 3. Please provide the STD elections on the census?

- 4. Is there a reason for the low STD participation (17 / 534 = 3%)? We typically require 25% participation to takeover a plan, will there be an opportunity to engage with employees and drive participation up? Does the district currently offer a competing STD plan??
 - A. Most of the employees remained with Aflac. There was low interest in new carrier in 2023 and the company did not really do a good job at reaching out to explain the benefits of plans. Douglas would love to have a company that explains the each plan to assist employees when making a choice.
