Affidavit of Residency

Before the undersigned officer, and being first duly sworn, I depose and state as follows:

That I understand that making false statements or submitting false documentation to the Taylor County School System and false swearing is a violation of O.C.G.A. 16-9-2, 16-10-20 and/or 16-10-71 of the criminal laws of the state of Georgia and punishable by a fine of not more than \$1,000 or by imprisonment for not less than one year, no more than 5 years, or both.
