

EDUCATIONAL SCHOLARSHIPS FOR STUDENTS

As part of our commitment to promoting higher education, Healthcare Plus Federal Credit Union is offering **three \$500 scholarships** to students seeking degrees.

ELIGIBILITY:

- The scholarships are available to high school seniors and students at a college, university, or vocational institution taking at least 9 credit hours, or attendance as otherwise approved by the scholarship committee. Applicants must be enrolled at an accredited post-secondary institution for the Fall 2024 semester as a freshman, sophomore, junior or senior. Graduate students applying must be enrolled in a minimum of six credit hours at an accredited post-secondary institution for the Fall 2024 semester.
- Applicant must be a current active member of **Healthcare Plus Federal Credit Union**.
- Applicant must be the primary or joint account holder in good standing.

REQUIREMENTS:

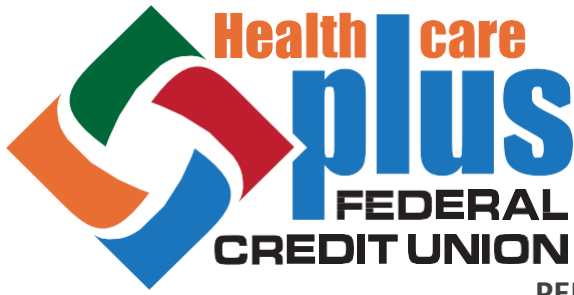
- Completed application
- Typed essay or video submission (video must be YouTube compatible)
- Copy of the most recent official transcript available
- Recent photograph for use in Healthcare Plus FCU promotional materials

JUDGING:

- Essay submissions will be evaluated based on content, spelling, grammar, and originality.
- Video submissions will be evaluated based on content, accuracy, quality, and originality.

SUBMISSION INSTRUCTIONS:

- Electronic applications may be submitted through email. Please use your name (lastname_firstname) as the filename and email it to: denise@hcpfcu.coop. You will receive an email confirmation that your application was received within a week of submission. If applicants do not receive confirmation, it is the applicant's responsibility to follow up with the credit union.

- Applicants must submit a completed application with all supporting documents/files attached by Friday, March 15, 2024. (Postmarked date) Late and/or incomplete submissions will not be considered.
