Mr. Forrester began the hearing by reviewing the allegations of the employee posting a picture of a student without parental consent and possibly putting the student in unintentional danger. Mr. Gardner, lawyer from Thrun Law, went over the legalities and violations that this action has made per FERPA laws and Board Policies.

Mrs. Day provided her side of the allegations. She shared information of her actions and expressed her apologies, but stated several times that she did not know she was violating any FERPA, and claims of not knowing what FERPA laws are. She admitted that making the post was wrong and took it down within 15 minutes of posting it. Mrs. Day was tearful while speaking.

Mr. Gardner gave Board members the opportunity to ask Mrs. Day questions. Mr. Carter asked a couple of questions.

Mrs. Julie Simmons voiced her support for Mrs. Day.

Mr. Matt DelTour voiced his support for Mrs. Day.

Ms. Brittany Michalec provided character testimony on Mrs. Day's behalf.

One of Mrs. Day's students spoke in front of the Board showing his support for Mrs. Day.

Mrs. Knapp spoke on Mrs. Day's dedication to the school. She stated that she is remorseful and has learned from her mistake.

Mr. Carter addressed the Board members and community members in support of Mrs. Day.

Ms. Ware addressed Mrs. Day with some questions and concerns that she has in regards to the alleged allegations. Mrs. Day repeatedly stated that she is sorry and knows what a serious mistake that she has made.

Ms. Abraham thanked everyone for coming. Ms. Abraham stated that she was concerned for her safety of the post and wondered if she had thought of the possible retaliation that she put herself and her family in.

Mr. Gardner asked a few more questions in regards to the situation that occurred the night before leading up to her actions creating the post. Mrs. Day struggled with answering her questions.

Mr. Brooks expressed how difficult this is for him and thanked the community members for showing their support and friendship toward Mrs. Day. Mr. Brooks addressed Mrs. Day and asked what is the main job of a paraprofessional. Mrs. Day stated that it is to keep the kids safe and provide them with education. Mr. Brooks asked a few more questions for his own clarification. Mrs. Day expressed lapse in judgment and states that she recognized what she did was wrong.

As advised by Thrun Law, Mr. Forrester recommended that the Board of Education terminate Mrs. Day's employment, effective immediately.
