Dear Parents/Guardians:

Children need healthy meals to learn. The **Woodbridge Township School District** offers healthy meals every school day. **Your children may qualify for free meals or for reduced price meals.**

Please read below regarding the Free/Reduced meals application process as some things have changed this year:

- 1. The annual income amount limits have been raised. This means that you may be eligible this year, when you were not eligible in years past.
- 2. You DO need to apply every year even if you were eligible last year to receive free/reduced meals. The status does not carry over.
- 3. You only have to fill out the application once per family. You do NOT have to complete the application for every child in your household, even if they go to different schools.
- 4. You do not need to submit an application if you were automatically approved or direct certified through SNAP (Supplemental Nutrition Assistance Program), TANF (Temporary Assistance for Needy Families) or Foster care.
- 5. Your US citizenship or immigration status does not affect your eligibility for free and reduced price benefits.
- 6. If you apply now and are denied and your situation changes, you may re-apply.
- 7. If your income is not always the same, put the amount you normally receive.
- 8. If a household member has no income to report, put zero in the field.

To access the lunch application, log into Genesis Parent Portal -

https://parent.woodbridge.k12.nj.us/woodbridge/sis/view?gohome=true and go to Forms. At the bottom of the screen, you will see the application. If you are SNAP, TANF or Foster Care, the APPLY tab will not appear as you are automatically certified.
