CDC signage on proper hand washing techniques will be posted throughout our schools. The district shall provide stakeholders the opportunity to wash hands often. The six steps to follow for proper hand washing (wet hands with warm water, use enough soap to produce lather, rub hands together for 15-20 seconds, wash hands thoroughly under running water to remove the soap, pat hands dry with paper towel, use towel to turn off the tap. Hand Sanitizer with 60% or greater alcohol content will be made available in all classrooms, common places, and offices. The following measures to contain respiratory secretions are recommended for all individuals with signs and symptoms of a respiratory infection: cover your mouth and nose with a tissue when coughing or sneezing, use in the nearest waste receptacle to dispose of the tissue after use, perform hand hygiene (hand washing with non-antimicrobial soap and water, alcohol-based hand rub, or antiseptic hand wash).

The district implemented air purification systems with the most effective environmental technology. EnviroKlenz devices have been situated in every learning and common space to effectively clean the air of viruses, bacteria, debris, and mold with UV lights and MERV 15 HEPA Filtration. Daily Surface Disinfection of the following: Door handles, toilet fixture handles, light switches, elevator buttons, student desks, cafe tables, exercise equipment, phones, keyboards.

The district has provided professional development to staff and parents on various relevant topics including data- based decision-making and accelerated learning. The district has implemented a data integration initiatives at each level to ensure teachers have access to high quality assessment information on an ongoing basis. The district hired additional instructional coaches and mental health coordinators to facilitate trainings for staff and parents. The district has developed a long-range SEL Platform for PD, SEL, Diversity, and Inclusion. The district has expanded our MTSS framework to enhance behavioral/SEL supports. The district has implemented after school and summer programs for targeted populations in grades K-12.

The district continues to work with stakeholders through committee meetings (administrators, parent groups, and school community members). The district will continue to obtain parent input in the 23-24 school year.

The district's ELL program includes translation and interpreting services as needed. To this end, we assure that parent communication (where indicated as necessary) is delivered in the preferred home language. District website information is available in Spanish and English. The district uses Talking Points language translating software as a two-way multilingual family engagement platform helping teachers and families to stay connected via text message/email. Documents are translated in-house with interpreting services from staff members when necessary. Additionally, interpreters are provided during meetings to assure parent understanding of information being shared. The district also purchased pocket translators for use at the building level. ADA supports: the district plans to utilize Microsoft speech to text to include audio narration. The district will also provide options to have the plan printed and mailed when requested.

The district has provided all staff with PD pertaining to student mental health needs. This will be expanded on in the 23-24 school year to include additional parent trainings, ongoing staff training and coaching, and student wellness days. The district has also applied for additional grants to continue to support this need.
