GUSD may require Universal and correct wearing of masks depending upon local health data including the rate of infection and spread. Students and staff over the age of four may be asked to wear masks correctly inside GUSD facilities and while using GUSD-provided transportation. A mask may be a cloth face mask, or disposable face mask. Face masks should be worn by staff and students as feasible and are most essential in times when physical distancing is difficult. If GUSD requires Universal and correct wearing of masks based upon local/statewide recommendation, then masks will be provided for those who cannot provide their own. Exceptions to this requirement include:

- 1. Individuals with a health condition, a communication or impairment, or a disability that prevents them from wearing a face mask.
- 2. When under the supervision of a school staff official who directs the mask to be removed; and
- 3. while individuals are eating, drinking, or exercising.

GUSD staff will modify facilities to allow for physical distancing (e.g., use of cohorts/podding) to increase spacing between individuals, including adjusted seating arrangements for school buses and classrooms and posted signs to remind staff and students of the importance of physical distancing. Classrooms will be modified to allow for physical distancing when feasible. The modified layout may include having individual desks, facing the same direction and offset. If tables are in the classroom, then students will only sit on one side of a table and will be seated apart. Students will be seated one to a seat on buses when feasible.

GUSD encourages proper handwashing and respiratory etiquette. GUSD encourages students to wash their hands for at least 20 seconds after blowing their nose, coughing, or sneezing; before eating, and upon entering classrooms. Breaks may be provided for hand washing. If soap and water are not available, hand sanitizer that contains at least 60 percent alcohol will be provided.

For respiratory etiquette, staff and students should cover coughs and sneezes with a tissue. Used tissues should be thrown in the trash and hands washed immediately with soap and water for 20 seconds. If a tissue is not available, then an elbow can be used to cough or sneeze in. Sanitizer can be used if soap and water are not available.

16. Please describe the LEA's Governing Board policy on cleaning and maintaining healthy facilities, including improving ventilation.*

Cleaning and maintaining healthy facilities, including improving ventilation will ensure the physical spaces, equipment, and materials students and staff come into contact with remain safe. Daily sanitation will be implemented for high-touch areas (doorknobs, handles, fixtures, etc.) with a medical-grade sanitizing solution. Transport vehicles, such as buses, will be disinfected daily. Restrooms will be monitored and cleaned more frequently throughout the day. Classrooms will be sanitized daily in high-touch areas. Sanitation will include the use of sanitization foggers. Medical-grade cleaning products will not be used near children and staff will ensure adequate ventilation.

Special education services for students with disabilities will include appropriate accommodations for children with disabilities with respect to health and safety policies that include increased time for synchronous instruction and explicit expectations for greater consistency. Appropriate accommodations will be designed to ensure the least restrictive environment as required by their IEP. As needed based on IEP goals, this will include in-person specialized instruction. Students will receive access to instructional materials for use at home, as needed, including assistive technology tools. The student support model will be complemented by enhanced professional development for staff and training for caregivers if necessary. When necessary, virtual meetings will be used to convene special education procedural meetings, such as local screening committees, re-evaluation, eligibility, IEP teams, etc.

GUSD will reinforce and enhance curriculum and supports focused on social-emotional learning, relationship building, and successful transitions whether in-person or through online, virtual, or distance learning. GUSD has purchased a grade-level curriculum that includes a focus on student social-emotional well-being. Staff will take training courses to help with social-emotional learning. All employees have access to an Employee Assistance Program, free of charge, through a third-party company called Jorgensen-Brooks. GUSD will continue to exercise aspects learned in Capturing Kids Hearts to include regular check-ins with each other, greeting one another, and genuinely expressing care for others.

29. How will the LEA ensure continuity of services for students' other needs?*

Other health needs may include health and food services. Food services will continue to provide meal services to students unable to attend school in person through Grab and Go meals which can be picked up in the school cafeterias and may be delivered to pre-determined bus stops.
