

# DRAFT K-12 STATEWIDE HEALTH TRUST MULTIDISTRICT AGREEMENT VERSION 1.0 - December 1, 2023

## ARTICLE I – TRUST NAME, STRUCTURE, AND MEMBERSHIP

This Trust shall be called the Montana Schools Health Benefits Trust (“Trust”). This Trust is formed as a multidistrict cooperative through the terms of this Multidistrict Agreement (“Agreement”) pursuant to the authority specified in § 20-3-363, MCA, and consistent with the provisions of §§ 20-3-366 through 20-3-370, MCA. This Agreement must be approved by the Board of Trustees of all participating districts and shall be for the maximum initial term of three years authorized by § 20-3-363, MCA. This Agreement shall also be automatically renewed for additional successive terms of three years each unless this Trust is dissolved pursuant to Article VII.

For purposes of this Agreement, the terms “district”, “district health insurance trust”, “employee” and “member” have the meanings defined in § 20-3-366, MCA.

This Trust has been created on \_\_\_\_\_ among participating districts identified in Appendix A. The initial members consist of \_\_\_\_\_ districts employing approximately \_\_\_\_\_ employees. The districts who are parties to the Agreement have agreed, through execution of this Agreement and upon approval of the State Auditor, to create a district health insurance trust as defined in § 20-3-366(6)(c), MCA, to participate in and obtain health insurance for their employees through the Trust.

The members of the Trust agree to comply with and avail the Trust of all privileges, flexibilities, rights, and benefits for such Trust as set forth in § 20-3-363, §§ 20-3-366 through 20-3-370, MCA, and all other applicable state laws governing this Trust.

## ARTICLE II – PURPOSE OF THE TRUST

The core purpose of the Trust is to provide high quality, stable, affordable health benefits for employees and officers of Montana’s public schools consistent with the provisions of Title 2, Chapter 18, Part 7, MCA.

## ARTICLE III - GOVERNING BOARD

**SECTION 1. GENERAL.** The Governing Board of Directors (hereinafter “Governing Board”) of the Trust shall consist of 25 voting directors, as further detailed in Section 4 of this Article, and the State Auditor (or the Auditor’s designee) as an ex officio nonvoting member.

**SECTION 2. INITIAL AND SUBSEQUENT TERMS.** The term of the initial directors of the Governing Board shall begin upon creation of the Trust meeting the qualifications of House Bill 332, 2023 Session of the Montana Legislature. The initial term of the initial directors of the Governing Board shall expire June 30, 2029. The second and subsequent terms of the directors of the Governing Board shall be for two years, with the first two year term beginning July 1, 2029.

**SECTION 3. BOARD COMPOSITION GOALS<sup>1</sup>.** The composition of the Governing Board is designed to:

1. Ensure representation of all members of the Trust by responsive and accountable public school employees and officers whose districts obtain health benefits under the Trust.
2. Ensure a board that collectively reflects demographic balance by position, location, district type, and district coverage category including representatives from both experience-rated and group-rated districts.
3. Encourage cooperation and collaboration among all public education leaders including certified and classified staff, trustees, administrators, and business officials;
4. Ensure representation that is proportional to the number of employees by district type that are eligible to obtain health benefits through the Trust from across the state of Montana.

**SECTION 4. PROPORTIONAL REPRESENTATION.** In furtherance of the goals of Section 3 of this Article, the 25 voting directors of the Governing Board shall be balanced by school type, position within schools, and, for directors elected under Paragraph 2 of this section below, by region as further detailed in this section.

To ensure representation by directors from as many school district members of the Trust as possible, there may be no more than one director from any single school system member of the Trust. In satisfaction of the board composition goals of Section 3 and subject to the provisions of this Section 4, the Governing Board shall consist of:

1. Ten directors selected by the unified school systems of the Trust that include high school districts participating in the Montana High School Association sanctioned activities in the AA athletic classification. The directors selected must consist of two certified staff, two classified staff, two trustees, two administrators, and two school business officials. The AA members of the Trust shall cooperate among themselves to ensure selection of directors meeting the requirements of this subsection; and
2. Fifteen directors elected by the non-AA members of the Trust who are respectively located in the nine Montana Association of School Superintendents ("MASS") membership regions as the regions existed on July 1, 2023, and as further detailed in the chart below. The fifteen directors shall consist of three certified staff, three classified staff, three trustees, three business managers, and three administrators.

The following is the progression of positions eligible for election or appointment by region<sup>2</sup>:

<sup>1</sup> This composition and the proportional representation in Section 4 is based on 100% participation by the eight largest school systems based on the number of certified staff members employed in such districts. Using fiscal year 2023, the eight largest school systems employed 5,119 out of 13,365 quality educator FTEs. This represents approximately 38.3%. Rounded up to 40% yields eight members on a 20 member board. If participation in the Trust does not include all eight of the largest school systems, this representation model would have to be revised to ensure proportional representation meeting the goals of this section. This explanatory note will not be included in the final governance document and is included here to explain the underlying rationale for the governance model.

<sup>2</sup> With 15 positions to be elected from among nine regions, it is necessary to ensure an equitable rotation of positions by region and role and to rotate the three regions eligible to elect two positions during each term.

**SECTION 5. VACANCIES.** If a vacancy on the Governing Board occurs, the AA district or region from which the director was selected or elected shall appoint a replacement to serve for the remaining duration of the unexpired term of such director. If the AA district or the region fails to appoint a replacement within 30 days of receiving notice from the Trust of such vacancy, the Governing Board shall appoint a replacement from that AA district or region to serve for the remaining duration of the unexpired term of such director.

A vacancy shall occur when a director resigns, no longer serves in or remains employed by the district in which the director served or was employed at the time of election, or fails to attend three successive regular meetings of the Governing Board without sufficient cause. The determination of sufficient cause for failure to attend shall be made by the chair of the Governing Board, with a right by the director failing to attend to appeal such determination to the Governing Board.

## ARTICLE IV - OFFICERS

**SECTION 1. GENERAL.** The Governing Board shall elect officers specified in Section 3 of this Article. Officers shall consist of an Immediate Past Chairperson, a Chairperson, Chairperson-Elect, Vice-Chairperson, and Treasurer. Terms shall be one year each. For the initial Governing Board, a Chairperson and an Immediate Past Chairperson must be designated by the Governing Board with subsequent immediate past chairpersons assuming such position through succession as specified in this Article.

**SECTION 2. BALANCE IN REPRESENTATION.** The officers must include one certified staff, one classified staff, one trustee, one business manager, and one administrator.

**SECTION 3. ELECTION AND AUTOMATIC SUCCESSION.** The positions of Chairperson-Elect, Vice-Chairperson, and Treasurer shall be elected by the Governing Board on an annual basis. The Chairperson-Elect shall, upon completion of the term of Chairperson-Elect, automatically advance to the position of Chairperson without election. Following the initial selection of an Immediate Past Chairperson under Section 1 of this Article, the Chairperson shall, upon completion of the term of Chairperson, automatically advance to the position of Immediate Past Chairperson without election.

**SECTION 4. ANNUAL ROTATION IN SELECTION OF CHAIRPERSON-ELECT.** Election of the position of Chairperson-Elect must be rotated on an annual basis, alternated between a regionally elected member of the Governing Board who has been elected to the Governing Board as one of the twelve regionally elected members and a member of the Governing Board who is elected to the Governing Board by the AA district members of the Trust.

**SECTION 5. DUTIES.**

1. The Chairperson shall preside over meetings of the Governing Board and undertake other duties of a presiding officer based on the latest version of Roberts Rules of Order for small assemblies.
2. The Chairperson-Elect shall serve as presiding officer in the temporary absence or abstention of the Chairperson.
3. The Vice-Chairperson shall serve as the presiding officer in the temporary absence or abstention of the Chairperson or Chairperson-Elect.
4. The Treasurer shall serve as the Governing Board's primary liaison to ensure compliance with applicable state and federal regulations regarding internal controls, financial reporting, auditing, and other financial matters.
5. The Immediate Past Chairperson shall chair any nominating committee as the Governing Board may create pursuant to Article V and shall otherwise be available to help preserve institutional memory and succession planning as the Governing Board shall request.

**SECTION 6. VACANCIES.** Should a vacancy among any of the officers occur, the Governing Board shall appoint another director qualified by position type and district type to serve for the remaining duration of the unexpired term of such director. The provisions for automatic succession under Section 3 and rotation in Section 4 of this Article apply to any director so appointed.

**ARTICLE V - POLICIES AND PROCEDURES OF THE GOVERNING BOARD**

The Governing Board shall adopt appropriate policies and procedures regarding the operation of the Trust. Such policies and procedures must be consistent with the terms of this Agreement and the provisions of §§ 20-3-366 through 20-3-370, MCA.

**ARTICLE VI – REQUIRED COMMITTEE STRUCTURE AND KEY DECISIONS**

THE Governing Board shall create an Advisory Committee through which the key decisions referenced under this Article must be delegated for development of recommendations to the Governing Board. The Advisory Committee shall consist of:

- Six certified staff and four classified staff designated by the Montana Federation of Public Employees;
- One school business official designated by the Montana Association of School Business Officials;
- One administrator designated by the School Administrators of Montana; and
- One trustee jointly designated by the Montana School Boards Association and Montana Rural Education Association.

Membership on the Committee must be formed from individuals employed by or serving in school districts other than the school districts with current members of the Governing Board. Key decisions that must be delegated by the Governing Board for a recommendation from the Committee prior to adoption by the Governing Board shall consist of decisions regarding plan design, underwriting and administrative structure. The Governing Board may also delegate other issues pertaining to the Trust for discussion and development of recommendations by the Committee.

**ARTICLE VII – CONDITIONS FOR EXIT**

Conditions for exit from this Agreement by any participating district shall be exclusively through district withdrawal procedures as set forth in § 20-3-367, MCA.



## ARTICLE VIII – DISSOLUTION AND DISPOSITION OF REMAINING FUNDS

As specified in § 20-3-366, MCA, the State Auditor may order the dissolution of this Trust if the Trust fails to comply with the provisions of §§ 20-3-366 through 20-3-370, MCA, or the rules adopted by the State Auditor. This Trust may also be voluntarily dissolved by both a two-thirds majority vote of the Governing Board to propose such dissolution and a two-thirds majority vote of the members of the Trust to so dissolve. Disposition of remaining funds upon any dissolution must be as provided by § 20-3-368, MCA.

## ARTICLE IX – LIMITED AUTHORITY TO AMEND THIS AGREEMENT

Following the initial adoption by all the districts that approve this Agreement and agree to join the Trust through such approval, any further amendment to this Agreement requires both a two-thirds majority vote of the Governing Board to propose such amendment and a two-thirds majority vote of the members of the Trust to approve such amendment. A vote cast by a member of the Trust shall be effectuated either by the Board of Trustees of each member voting, or, in the case of collective bargaining provisions in a district specifying ownership of the district health plan by a union, by the elected union leadership serving under the terms of such collective bargaining agreement.

Any amendment proposed to this Agreement by the Governing Board must be provided at least ninety days in advance of the vote to each member of the Agreement.

## ARTICLE X – CONDUCTING BUSINESS THROUGH ELECTRONIC MEANS

The Trust may conduct any business via technology and/or other electronic means. Therefore, any reference in this Agreement to written notice, mailings, signatures, distribution of information, conducting meetings, or otherwise conducting any business of the Trust shall be construed to specifically authorize such conduct in whole or in part through technological means. Such authority shall include, but shall not be construed as being limited to, video and conference calls, electronic ballots, electronic meetings, and elections.

## ARTICLE XI - MEMORIALIZATION OF AGREEMENT AND INITIAL MEMBERS

This Agreement may be and has been executed in counterparts by each participating district as defined by § 20-6-366(5)(b), MCA, and employee group consistent with § 20-6-366(3), MCA. This Agreement and all counterparts together shall constitute the same Agreement. In the event that any signature is delivered by facsimile transmission or by e-mail or other electronic delivery of any kind, such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such signature page were an original thereof.

The districts, cooperatives, and employee groups who have created this Trust and who are the initial members of this Trust are as follows:<sup>3</sup>

Success of this Trust will require support from nearly every school district. No one has sufficient districts and employee lives to qualify for the Trust without collaborating with others.

1. Districts currently obtaining coverage from MUST have approximately 4,700 covered lives.
2. AA and other Self-Funded Districts are estimated to have approximately 5,800 covered lives.
3. Remaining districts who are neither in MUST nor self-funded are estimated to have approximately 4,000 covered lives.
