Minutes of CONNEAUT BOARD OF EDUCATION REGULAR MEETING

April 19, 2023

The Regular Meeting of the Conneaut Area City Schools Board of Education was held on Wednesday, April 19, 2023 at Conneaut High School. The Regular meeting was preceded by a work session that began at 10:00 a.m.

Work Session: Mr. Eric Kujala provided a safety update he provided the Board with an updated Crisis Response Action Information sheet that had been created from the work of the District Safety Committee, which exists of 15 district staff across all buildings, meeting monthly to update and identify issues and necessary trainings, establish safety as part of the strategic plan and create recommendations for increased safety. He also reviewed the multiple safety initiatives and training that had been addressed and/or completed as a result of HB123 Safety and Violence Education Student Act in coordination with planning an implementation by the safety committee. Mr. Kujala noted also that the district had held a district wide functional drill involving local safety personnel in November on a professional development day. Mr. Kujala highlighted that the district had been awarded a \$200,000 School Safety Grant and an additional \$40,000, three to one matching grant from the Ohio Bureau of Workers Compensation. He also reviewed how the work that the Safety Committee has done supports the district's strategic plan for goal 5, objective 1.

Mr. Nathan Wise, National Honor Society Advisor, provided the board with an updated agenda of a one-day trip proposal to Niagara Falls for NHS students. Mr. Wise verified that students would be transported by vans which could accommodate 18 students total and that the trip would include visitation of sightseeing and events on the United States side only. The cost to each student would be approximately \$40.00 for food purchased at their own expense. Tickets for events will be covered.

Mrs. Lori Riley, Superintendent, shared the revision to the 22-23 school year calendar, with June 12 being the last student day and June 13 being a professional development day for staff and June 14 being the last teacher workday. The calendar change was necessary to accommodate required professional development training before the 2023-2024 school year professional development could begin.

Committee Reports:

Legislative – Mr. Coltman shared that last week several additional bills had been introduced regarding home schools and charter schools and encourages all to continue to watch closely on how they develop.

A-Tech – Mr. Nesbitt shared that A-Tech would be having their annual plant sale and continue to seek a portion of funding from OFCC for construction to support expansion of programs.

Athletic Council/SPARC– Mr. Brecht shared that representatives of the SPARC committee had the opportunity to tour Jefferson locker room facilities in their field house for additional ideas to meet the needs of athletes.

Student Achievement Report and DLT – Mrs. Armeni noted the DLT team is creating a PBIS attendance team to support an absenteeism initiative as data results they are reflective of the high impact that absenteeism has on student learning.

City Council – Mrs. Norton announced the Spartan Student of the Month was Amelia Sanford for April. Mrs. Norton also noted that Joint City Council meeting that was to be held April 19 at 6:00 p.m. has been postponed until September.

Board President – Mrs. Norton reminded visitors, parents and staff that May 2, the Conneaut Area City Schools Board of Education had placed a new 2 mill permanent improvement levy on the ballot. If passed the new levy would begin collection in January 2024 and the board would work with the County Auditor to discontinue the existing 1.5 mill levy effective for January 2024. With the discontinuation of the existing 1 mill bond and .5 mill bond maintenance fund as of the second half of 2023 collection, voters and property owners would see a reduction in tax collection beginning in January 2024.

Superintendent's report: Mrs. Riley shared the district was invited to participate in a pilot program with Ashtabula County Court System in coordination with Community Counseling regarding chronic student absenteeism. She hopes to see mediation steps prior to the court process that will assist in keeping students in school.

Treasurer's report: Mrs. Miranda noted the fiscal office met with Student Activities advisors in a group setting to review required audit procedures and guidelines, use of Hometown ticketing, and end of year events. Fiscal office is preparing for end of year processes by reviewing all grants, including ESSERS grants, and the five year forecast to bring to the board for approval in May.
