July 19, 2023

The Regular Meeting of the Conneaut Area City Schools Board of Education was held on Wednesday, July 19, 2023 at Conneaut High School. The Regular meeting was preceded by a work session that began at 10:00 a.m.

Work Session: Mrs. Riley, as acting maintenance supervisor, shared with the board the custodial staff is short approximately two weeks due to the school calendar dates this summer but are making great progress to prepare buildings for the 2023-2024 school year. The buildings are still active with Safety Town, band, choir and theatre camp, and assorted athletic activities. Mrs. Riley shared that ACCESS staff continues to provide the students of our district with great opportunities and are still needed. She also shared that CACS had been selected by Ashtabula County Courts to participate in an Early Intervention Truancy Behavioral Agreement with funds from the Stronger Connections Grant from ODE to help offset the cost. Mrs. Riley shared that Mr. Mike Kennedy has resigned from his the A-Tech Board member position as the Conneaut representative and the board will need to appoint a new individual to represent Conneaut Area City Schools. Mrs. Riley also reviewed the first reading of several board policies with the board holding discussion on the necessary requirements for non-staff coaches and volunteer staff.

Mrs. Miranda reviewed items listed on the agenda for board approval.

Public Participation: Mrs. Julene Edwards, 652 Lake Erie Street, Conneaut, OH 44030, shared with the board her interest and concern about acquiring additional handicapped accessible playground equipment for Lakeshore Primary School. Mrs. Edward volunteered to assist in the process. Ms. Nicole Edwards, also from Conneaut, supported the interest and concern about acquiring additional appropriated adaptive equipment.

Committee Reports

Legislative – Mr. Coltman shared the budget process was completed with the Governor DeWine signing the budget bill on July 3, 2023

A-Tech – Mr. Nesbitt reported that the potential A-Tech expansion project was still on hold as they were waiting for a response on funding.

Athletic Council/SPARC– Mr. Brecht reported the Athletic Council had not met. The SPARC committee had met on June 28 with discussion occurring on the future of a field house, built through private donations to the school district. Mr. Brecht also reported that thru private donation, the corner of Stadium and Reig Avenue is being developed to include a Veteran's memorial and flagpole. Also discussed was the need for replacement lighting at Joslin Field and Ricaurte Stadium and initial lighting for Eighmy Track and Garcia Soccer Field.

Student Achievement Report and DLT – Mrs. Armeni had no report.

City Council – Mrs. Norton had no report.

Board President – Mrs. Norton had no report.

Superintendent's report: Mrs. Riley reviewed the recently signed biennium budget bill. She also shared the D-Day would be occurring August 17, 18 and 19, with only twelve-month staff working on August 18 as D-Day utilizes parking and grounds area at several of our school buildings in cooperation with D-Day Ohio.

Treasurer's report: Mrs. Miranda reviewed agenda items and also explained the final step for board approval to present a levy to district voters. Mrs. Miranda also explained to the board purpose and structure of the additional permanent improvement levy for November 7, 2023 election. The summer of 2023 property tax collection concludes the bond collection for construction of CMS, GES, LPS structures and the renovation of CHS (002 fund), along with the maintenance fund bond collection (034 fund) that voters had approved in March 2000. The board is proposing to the voters of the district to replace the expiring bond collections (total of 1.5 mills) with a 2.0 mill permanent improvement levy and if approved the board would work with the county auditor to rescind the remaining collected to 2.0 mills collected. Mrs. Miranda also explained that according to Ohio Revised Code, the ballot language must read the levy is an additional tax, even though overall it is a reduction in millage for property owners.
