Title I School-Level Parent and Family Engagement Policy Barrington Elementary School

Barrington Elementary School has developed a written Title I parent and family engagement policy with input from Title I parents and family members. An annual meeting of parents of participating Title I students is held to explain the goals and purposes of the Title I program, jointly develop a parent involvement policy, and review Title I parent complaint procedures.

Parents are given the opportunity to participate in the design, development, operation and evaluation of the parent involvement program, including making spending decisions regarding Title I Part A funds reserved for parent involvement and review sites Single Plan for Student Achievement. Throughout the year, parents are encouraged to work with site administrators, teachers and staff and give input on overall school and student needs as well as Title 1 expenditures and Single Plan, focusing on improving student learning and academics based on state and site test scores.

Title 1 parents are invited and encourage to attend the following meetings: School Site Council (SSC), Site English Learner Advisory Committee (ELAC), Second Cup of Coffee, District English Learner Advisory Committee (DELAC), Local Control Funding Formula (LCFF), Local Control and Accountability Plan (LCAP) input meetings, Back-to-School Night, Parent/Teacher Conferences and school board meeting to review current plan, policies and programs, evaluate effectiveness and provide input. The policy is distributed to parents via Barrington website, ClassDojo and hard copies are available in the front office. The policy describes the means for carrying out the following Title I parent and family engagement requirements [20 USC 6318 Section 1118(c),-(g) inclusive].

Involvement of Parents in the Title I Program

To involve parents and family members in the Title I program at Barrington Elementary School, the following practices have been established:

- a) The school convenes an annual meeting, at a convenient time, to which all parents of participating children shall be invited to attend and encouraged to attend, to inform parents and family members of their school's participation in the Title I program and to explain the requirements, and the right of the parents to be involved. (20 USC 6318 (c)(1)
 - This year due to COVID-19, the annual meeting will be held the first month of the school year at the first SSC, ELAC and any following Second Cup of Coffee meeting of the school year which is held within the first two months of the school year and then at a minimum four times a year for SSC/ELAC meetings.
- b) The school offers a flexible number of meetings, such as meetings in the morning or evening, and may provide, with Title I funds, transportation, childcare, or home visits, as such services relate to parent involvement. (20 USC 6318 (c)(2)). This year those meetings may be through Zoom or in person.
 - School Site Council/ELAC and DELAC meetings are held four times a year after school or as needed to inform parents of Title 1 process, Safety, Attendance, State and Site academic progress, funding status, allow evaluation of plan, Site Plan for Student Achievement progress and address questions. These meetings offer parent's time to be involved in the

decision making of the school and provide input. Administration is available daily to answer questions or clarify information.

c) The school involves parents in an organized, ongoing, and timely way, in the planning, review, and improvement of the school's Title I program, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the school wide program plan. (20 USC 6318 (c)(3))

The plan, including budget, starts at the ELAC committee level and is developed for the current school year based on current and past student data. It is then reviewed and discussed by the School Site Council and modifications or changes are made. Once SSC approves the plan in the Single Plan for Student Achievement it is submitted to the Superintendent. The plan (in its entirety) is reviewed by the Superintendent then submitted to the Governing Board for another review and approval.

- d) The school provides parents of participating students with
 - 1. Timely information about the Title I program. (20 USC 6318 (c)(4)(A)):

Information concerning the Title 1 program is distributed via Class Dojo, Phone Dialer, Barrington's website, PTC, ELAC/DELAC and SSC meetings. Letters are mailed home concerning details of the Title 1 program.

2. A description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards. (20 USC 6318 (c)(4)(B))

Barrington uses state adopted curricular materials that are approved by the local LEA. These materials are reviewed each year and updated as required. Students have one-to-one technology access via Chromebooks or IPads. Computer programs used include: Lexia, Dibels, Stride Academy, Zearn, Mystery Science, Accelerated Reader - STAR, Renaissance, CAASPP IAB's, Practice tests and ELPAC Practice tests and data, Typing training, Ellevation, and ESGI (Educational Software for Guiding Instruction). Intermediate Assessment Benchmarks are used throughout the year to gauge progress toward State academic standards. This data is compiled and reviewed by teachers during PLC, Collaboration Meetings, Staff Meetings and Teacher Prep time to assess whether re-teaching is needed for optimal student performance.

- If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible. (20 USC 6318 (c)(4)(C))
 - School Site Council and ELAC meetings held a minimum of four times a year or as needed to address school, parent or committee decisions
 - Monthly LEA Board Meetings
 - LCAP/LCFF stakeholder and parent input meetings
 - Meetings with Administration
- e) If the school wide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency. (20 USC 6318 (c)(5))

• Contact parent, hold conference or meeting with parent, and address concerns at our SSC, ELAC, DELAC, LCAP, LCFF, Second Cup of Coffee or meetings with Administration to formulate ideas or further discuss concerns.

Building Capacity for Involvement (Parental Involvement Policy continued)

To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, each school and local educational agency assisted with Title I, Part A funds, the school has established the following practices:

 - Progress is also discussed at Parent/Teacher Conferences that are held at progress report time. Progress toward standards, proficiency, and any academic adjustments are reviewed and implemented for individual student success.
 - Address any questions parents may have on student's attendance or engagement.

School-Parent Compact

Barrington distributes to parents and family members of Title I students a school-parent compact. (During COVID – 19 Hurd Barrington follows the guidelines from the NCLUSD, Stanislaus County Office and of Education, the California Department of Education, along with Stanislaus Public Health for student safety and help meet their academic needs.)

The ways in which each parent will be responsible for supporting their children's learning; volunteering in their child's classroom, chaperoning field trips and other extra-curricular activities, acting as a parent tutor for struggling students, participation in school-wide events. (Due to COVID this part cannot be implemented, but parents may support their child by keeping an open communication with their teacher, administration and the school and attending parent meetings and offering feedback through survey's sent out both from site and district office.)
 - 2. Parental participation, as appropriate, in decisions relating to the education of their children and positive use of extracurricular time. Parents are invited to attend any school function, extra-curricular activities, SSC meetings, ELAC meetings, DELAC meetings, Parent/Teacher conferences, IEP meetings, SST meetings, 504 meetings, LCFF/LCAP meetings and meetings with administrators that may support their children's needs. All these meetings can be held in person or through Zoom.

 - 4. Ensuring regular two-way, meaningful communication between family members and school staff in a language that family members can understand. All correspondence is sent in two languages, English and Spanish. Many of our office staff and administrative team are bilingual and can assist with technology concerns, filling out of forms, and general information concerning any school activities.

Open communication is key during COVID-19 through, phone calls, text through ClassDojo and Zoom Meeting to ensure student success.
