 - \$481,418 (20%) Allocated for evidence-based interventions to address learning loss. FADOR

- Learning Environment
 - We will continue to utilize mitigation strategies, such as but not limited to: recommended use of face coverings, sanitizing, frequent handwashing, use of air purifiers, and social distancing.

VEADOR

- Instructional Format
 - Instruction will return to a pre-covid, face-to-face operation focused on maximizing instruction, collaboration, and student learning.

- Student Attendance
 - Students who are unable to attend on-site will be counted absent.

Support for students unable to attend school will return to

- o pre-covid operations.
- Extra-Curricular/Co-Curricular Activities
 - All activities will be based on guidelines provided by the IHSAA, IHSGAU, or IHSMA while following district guidelines.

- Health and Safety Measures
 - Face coverings required grades PK-8 and encouraged 9-12
 - No contact training will be completed
 - COVID-19 illness is treated like any other illness
 - Hand hygiene and sanitizing is promoted and completed daily in school buildings.
