I. CALL TO ORDER, ROLL CALL AND FLAG SALUTE

The meeting was called to order at 5:30 pm by Chair Lisa Rietmann.

II. AWARDS, RECOGNITION AND CORRESPONDENCE

- ASB Report – Chelsea Geer
 - Sold candy grams and netted a profit of \$200.00.
 - This Friday is the Surf and Turf Dinner as well as the alumni basketball game.
 - Funds from the dinner will go towards students attending the Oregon Association of Student Councils in April
 - Student body elections will be held in early April.
- Union Report – Cheslea Geer

- Focus is how to involve the community more. Some ideas are art collaborations, local book fairs, bulletin boards, teaching a specialized lesson, class cleanup.
- Group is taking a family connections class.
- Committee Report – Gus Peterson (Spokesperson for Cardinal Community Committee)
 - Our last meeting was highly successful – a lot of ideas were shared.
 - Survey was sent out to students and staff asking what the community do to improve the connection to the school. Some highlights are:
 - Students:
 - More hands on activities
 - Connections amongst all grades
 - Support for students and staff as well as just greater options across the board.
 - Staff:
 - More CTE
 - Create short and long-term goals.
 - More parental support
 - Other ideas that were generated from the committee:
 - Big buddies (implementing)
 - Career/alumni day at end of year
 - More student/parent celebrations
 - More dinners like the thanksgiving.
 - Next year we are developing a kindergarten support plan.
 - Meeting again in March – this was an added date.
- Bond Report – Ed Champane and Earl Eastman, Project Managers
 - Some nice milestone things have been achieved/started.
 - Completed pre-installation meeting with Port of Morrow at the football field site.
 - Completed pre-installation meeting with the helical anchor contractor.
 - Started excavation of concrete pier footing holes, installation of the main electrical vault and beginning helical anchor installation.
 - Ordered the building that is going to be at the track and field site.
 - Ran into some unforeseen costs related to the helical anchors due to the electrical and water lines that feed the elementary school. Those will need to be relocated.

III. PUBLIC PARTICIPATION

Community member Gus Peterson shared his concerns regarding the declining enrollment numbers and discussed what can be done as a community to increase the enrollment. . We need to be building strategically towards something. Need to draw kids from other schools to exist. Need to be something special. CTE pathways are a potential option.

Ione student Zamira Dotson expressed her concerns with the new bond construction about moving the shop across the street and into the regular school area. She feels there will be a loss of space at the new location, the noise of the shop class may affect the nearby classrooms and may be distracting to other students, and it would cost a lot of money for the ventilation that would need done. She also mentioned possibly adding more stop signs on the road to make it safer for students to cross if the shop was able to stay at its current location.

In response to Zamira's concerns, the board mentioned that the extra classrooms that are being built next to the new shop are not going to be occupied as of the current plans. There will also be roll-up doors and a large room for storage.

Tracey suggested possibly setting up a meeting between the bond spokespeople and the students so any questions could be answered.

 - Enrollment total is at 119 - staying steady.

 - School and State Update

- Last week fiddler, Kelly Thibodeau, came to the district and provided fiddle lesson for all students K-12. Parents were invited to a recital.

A. Football Co-Op Discussion – Ryan Rudolf

E. Approval of 2024-25 InterMountain ESD Local Service Plan

IMESD Superintendent, Mark Mulvihill presented the 24-25 Local Service Plan that all IMESD component districts are required to vote on each year. He explained what the LSP is and how it relates to Ione School District. The LSP focuses mainly on four core service areas, which are decided by the districts. The four areas are: Special Education, Technology, School Improvement and Administrative Services.

After a question regarding trouble with getting technology services in Ione, Mark mentioned there is some restructuring going on and next year they are adding some staff to help serve the increased population in Morrow County.

BE IT RESOLVED, upon motion by Rob Crum and seconded by Paola Cabrera that Resolution 2024-005 InterMountain ESD Local Service Plan for 2024-25 be approved, as presented. Rob Crum, Lisa Rietmann, Ed Rietmann, and Paola Cabrera voted yes. Liz Peterson did not vote. The motion passed.
