### Principal's Message

Welcome to our school. Foothill is not the typical Community Day School. We offer our students the opportunity to succeed academically, as well as becoming involved in the community through service projects.

Foothill CDS implements a curriculum that is focused on English, Math, Science, and Social Studies. We also offer elective courses that can be taken in conjunction with core classes through Edgenuity. This Internet-based program gives us the freedom to design the curriculum for each individual student and for students to work at their own pace. Our goal is to give our student's a standards-based education and help them to become successful.

Our 2023-2024 Foothill enrollment consists of 5 students. The ethnic demographics include 60% Hispanic, 20% African American and 20% identify as Multiple Ethnicity. We also have 50% of our student population as English Learners and 100% of our students receive free lunch.

With our small class sizes, students who may not have had the opportunity to make decisions in the District's traditional, much larger schools, have a voice in the decisions made at Foothill. Foothill offers students the opportunity to take a leadership role by offering a Student Leadership Team. This team meets with Foothill's teacher and administrator to make decisions for the school, in regards to activities that they may earn.

Staff and administration are committed to delivering the curriculum and guidance to encourage student success. We take pride in creating opportunities for students to succeed academically and developing into productive members of society. Each student should leave as an:
