It was a banner year for the Cody-Kilgore Track and Field teams. Multiple school records have

fallen, not to mention countless personal bests recorded. The season culminated in three CK athletes qualifying for the NSAA State Track and Field Championships hosted at Omaha Burke High School in Omaha, Nebraska. CK seniors Dylan Naslund and Urte Noreikaite, along with then-junior Aubree Johnson exemplified CK's emphasis on demonstrating respect, integrity, determination, and excellence.

At the state track meet, Johnson, Naslund, and Noreikaite took turns on the podium after securing appearances in the finals of the respective events: Johnson in high jump. Naslund in shot put and discus, and Noreikaite in discus. Johnson qualified in the 200 meter run, but failed to make it out of the preliminary round. 

We ended up eighth in the roping and won \$650. That night, I felt so accomplished but I knew the next day was going to be even better. I drew a guy from Whitewood, South Dakota in the 8.5 roping. This roping was also a three head. Cason was my heeler's name and we had two clean runs in the first two rounds. Coming in to the short go, we were third high call. I was a nervous wreck going into the short round. All I had to do was get a clean time and I would win big. Some teams before us went out and had no times. This made me even more nervous. When it was our time to go, I cleared my head and did my job. Cason did his job on the heel side and we were sitting first with two teams to go. Second high call team went out and missed. One team to go and I was on top of the world. The high call team missed their steer too.



Cason and I ended up winning the roping and \$3250 a piece. The weekend treated me well and I walked out of Rapid winning \$3900 while clearing \$2400. I am looking forward to next summer, that's for sure.

Despite their new-found celebrity status as heroes, the Schied boys remain grounded in humility.

"Someone needed help, so we helped," Traper quipped as he summarized his adventure in a way that only Tom Osborne could top, in terms of stoicism. When asked about all the media attention, both Traper, a CK junior, and Chase, a CK 7th-grader, thought it was cool, but they both stressed that they didn't understand because, as they said, in the Sandhills, people rely on each other. "Our neighbors needed help, so it wasn't a hard decision to make," Traper said.

The decision to help may have been easy to make, but the trip was arduous. The boys had to travel 10 miles as the crow flies, which isn't usually an issue. The problem that complicated the situation was an historic blizzard that stretched an easygoing ride next door to about 30 minutes of navigating through whiteout conditions. When asked how they made it through the storm, Traper acknowledged his phone helped, but he also used area landmarks to help guide the two of them to their destination. "We used my phone, but we also kept a lookout for trees and fences and stuff," Traper said.

During the annual Cody-Kilgore Awards Night in May, Traper and Chase were both recognized by the American Legion Auxiliary when Jean Vackiner presented the brothers with the American Legion Youth Hero Award.


Not to be outdone, former Nebraska Governor, Pete Ricketts added a special honor of recognition for their valorous deeds: he commissioned Traper and Chase as Admirals in the Nebraska Navy. True to form, the boys appreciated the attention, but downplayed their heroic status. "It's cool




### CK FFA gearing up for another year of Ag-focused education

# HEADLINES FROM A BYGONE ERA


This feature of the CK Beat will take a look at the history of the Cody-Kilgore area through documents preserved by our local historian, and cookie aficionado, Ms. Richie.

#### **CK Gridiron Glory**

1970 - The football team completed their first undefeated season in their football history. The Cowboys scored a total of 296 points to their opponents 50 points.

1972 - The football team had their second undefeated season in three years. They averaged 38 points to the opponents 7 points.

1974 - The football team played their first 11-man game in the history of Cody-Kilgore.

#### Commercial Hotel/Diamond X

In 1903 I.C. Stotts announced he would build a hotel in Cody on the north side of Nebraska Street, facing south to the Spark Bros. general store. He figured the cost would be \$3,000 for a 30'x70', 2-story building. The name would be the Commercial Hotel and would include a restaurant. Stotts paid \$150 for the lot in 1904.

Due to a shortage of help in 1909 the Commercial was closed for a while. It would be interesting to know if there really was a shortage of help or a management/employee problem.

The Commercial Hotel became less of a hotel and more of a cafe during the 30s. The name changed to the Diamond X Cafe with a billiard hall in the building. There is a high probability of illegal activities in the "unused" hotel rooms.

The owner, Jack Stotts, had the cafe interior decorated with 130 paintings of cattle with brands and ranch name.

Before the building was demolished, ranchers were able to attempt to remove their brand painting from the lath and plaster walls.

Jack brought in a cook/gambler for the Diamond X. Tommy Miyao came to the United States from Hiroshima, Japan around 1906. Tommy always had a pot of chicken soup on the stove and cooked aged steaks to perfection.

Tommy was a cook, a gambler, and a drinker. The drinking caused his death. He always had a shot of whiskey and chaser

in the morning at Stotts' Drugstore. That fateful day the cleaning lady had sat a glass of ammonia water on the counter and he drank that as a chaser. After several days in the hospital he died, January 21, 1963. He is buried in Cody's Prairie Lawn Cemetery.

The Diamond X was torn down in the 70's.
