Because it is essential that the Superintendent be able to confirm that the student and the student's parent(s) or guardian is a resident of the Town of St. George, you need to bring some documentation with you to demonstrate residency when you have this form signed by a Town Official. The following are common forms of documentation that can be used to demonstrate residency:

1. A current, valid driver's license with a St. George address;
2. Confirmation of St. George voter registration;
3. A St. George Homestead Exemption;
4. The mailing address on your most recent State or Federal Tax return indicating St. George;
5. A court order awarding parental rights and responsibilities and specifying the child's primary residence.

In addition, for students who have one parent/guardian who resides in the Town of St. George and one who resides *somewhere other than St. George*, please attach a copy of the agreement or court order that is currently in effect or other documentation that can confirm the student's legal residence. Legal residence means that place in which a person's habitation is fixed and to which that person, whenever absent, has the intention to return. A person can only have one legal residence at any given time.
