Absence

Teachers are to take attendance at the beginning at each class period. Absences are classified as:

1) excused or 2) unexcused. An excused absence is for the following:

1. Medical, dental or optical appointments. (If possible, please arrange these appointments on Fridays). Confirmation of appointments may be required.
2. Illness of the student.
3. Official school trips or school-sanctioned activities.
4. Approved religious holidays and mandated court appearances.
5. Reasons approved by the superintendent prior to the absence upon showing good cause.

6. Illness of an immediate family member when the student's presence at home is necessary.

7. Death in the family, or some other significant family emergency outside the control of the student or the student's family.

If you are absent for any reason, notice from a parent must be given to the office as soon as possible, ***preferably*** before the start of school.

Tardy

You are on time to class if you are in the classroom before the bell rings. If you are reported tardy three times in a quarter you will receive a discipline referral (detention).

Late School Work

Students must follow all assignment instructions and due dates given by the teacher, unless prior arrangements have been made with the teacher.

Lockers

Lockers in the high school are assigned to students for the use of storing textbooks, school materials, and the personal items of each student. Leaving unattended backpacks, bags, books, etc. on window ledges, on the floor or stairs is a safety hazard and will result in a discipline referral. Students are urged **not** to place valuable articles in their locker. If you wish to lock your locker, combination locks can be provided to you by the office. **Personal locks are prohibited.** Lockers and other district storage areas provided for student use remain under the jurisdiction of the district even when assigned to an individual student. The district reserves the right to inspect all lockers. A student has full responsibility for the security of the locker and is responsible for making certain it is locked and that the combination is not available to others. Valuables should never be stored in the student's locker. Lockers may be routinely inspected without prior notice to ensure no item which is prohibited on district premises is present, the maintenance of proper sanitation, mechanical condition and safety and to reclaim district property including instructional materials.

Breakfast and Lunch Program

Breakfast is served daily in the cafeteria from 7:30 am to 7:50 am. Lunch is served daily at 11:30 am for students in grades K-6th grade and 11:52 am for students in 7th-12th grade. Students eat free of charge and are allowed one serving of milk at each meal. If a student is allergic to milk they will be served an

alternative with a doctor's note. The cost of breakfast is \$2.67 and lunch is \$4.41 for adults. Parents and community members are welcome to purchase either breakfast or lunch while visiting the school, but we ask that they call the day before to ensure that sufficient food is planned and prepared.

***Food is no longer allowed to leave the cafeteria.**

Students are expected to follow the cafeteria rules:

1. Enter the cafeteria quietly and slowly
2. Wait in line quietly and be prepared to make your food choices
3. You must take a fruit or vegetable and 2 other items
4. You may ask for seconds after you have finished your 1st serving
5. Keep your hands and feet to yourself
6. Talk in a voice that can be heard across the table, not across the room
7. Stay in your seat
8. Use good manners (napkin, chew with your mouth closed, no burping)
9. Clean up your table area and under your seat before leaving
10. All elementary can leave the lunchroom at 11:50 pm and return to class.

Attire and Grooming

In selecting clothes appropriate for school, the student should always remember the general rule is to use common sense. Specifically, students should not wear the following to school:

1. Clothing displaying vulgar writing, symbols, or sexual references
2. Clothing with alcohol, tobacco, or controlled substances advertisements or references
3. Clothing should not be distracting to others. The following are helpful guidelines:
 - a. Hems of shorts or skirts must be below fingertips when arms held down to the person's sides
 - b. Spandex pants or shorts must be worn ***underneath*** skirts or non-Spandex shorts/pants
 - c. Shoulder straps are to be at least $\frac{3}{4}$ " and should not hang below the arm pit
 - d. Necklines and waistlines are not to be revealing of cleavage
 - e. Midriffs (front and back) are to be covered.
 - f. Team practice clothing is not to be worn other than at practice.

Students will be asked change his/her attire or cover up if it is determined by a staff member that the clothing is distracting to others. The wearing of hats in classrooms is up to the teacher. **Hats must be removed in the library, computer lab, front office and during school day assemblies.**

Skateboards, Scooters, Bikes and Other Non-Motorized Apparatus

For safety reasons, as well as potential liability for the school, these items are not to be ridden on school grounds at any time. Exceptions for elementary students will be made for use of scooters and roller-blades (skates) with permission and the use of proper safety equipment (helmet) and only on the tennis court. Scooters and skates may not be shared. High school students are not allowed on the elementary playground or on the equipment that is intended for the elementary students (i.e. swings, slides, scooters/skates). Furthermore, elementary students are not allowed chewing gum on the playground.

Automobiles

Students who wish to drive a motor vehicle to and from school must register in the office each school year. Information required will include but not be limited to:

1. A copy of your valid Oregon driver's license
2. A copy of your vehicle registration
3. A copy of your proof of insurance
4. The signed statement that you understand and will comply with district and school rules
5. No other students are allowed in your vehicle while on school grounds (other than siblings)

*Note – Driving privileges may be suspended for failure to comply with rules stated in this handbook.

Students who drive motor vehicles to and from school may not use them or enter them from the time they arrive in the morning until the end of the regular school day, unless they have a signed note from the parent or guardian on file in the office requesting such privileges and have **signed out** in the office as required.

At no time during the school day or school activities shall students transport other students in a motor vehicle. An exception to that rule exists for siblings with parent permission. Spray dorm students are not allowed to be transported by a student **at any time**. Student parking is the area behind the shop but not to block the fuel tank. Students are not to park in any other area without special permission from the superintendent. Parking or driving on school property constitutes acceptance of the school rules and policies, including the school's right to search any vehicle on school property upon reasonable suspicion.

School Boundaries for Open Campus

Students in grades 7 and 8 must have a parent's note giving permission for the student to leave campus during morning break and/or lunch break. Students in grades 9 -12 are allowed to walk or drive from campus during morning break and lunch within the boundaries of the Spray city limits. At all times of the school day, **the football field, rodeo grounds, and the road around the grounds are off limits**, unless you are with a teacher. Dorm students (in either dorm) are **not** allowed to go to their dorm anytime during the school day ***without express permission from the dorm parent and not for lunch.***

Eating in the Classroom

No food or beverages, other than a drink with a spill-proof lid, may be brought into the classroom.

Classroom social/incentive activities planned by the teacher are the only exception in which food and drink containers must be deposited in one of the **outside trash receptacles**. **Please do not put food or food containers in an indoor trash can.**

Leaving the Classroom During Class

Students can be given permission by a staff member to leave the classroom to use the restroom, go to the office or another classroom for educational purposes (not to collect their Chromebooks).

Students are not allowed to leave the campus during class time unless excused by a parent in advance for a pre-arranged purpose (family business). If students leave class to prepare for departure to a field trip or sporting activity, leaving campus during class time will be under the discretion of the coach or head chaperone.

Cell Phones, Cameras & Electronic Devices

Cell phones, smart watches, ear buds and personal or school computing devices (smart phones, tablets and laptops) are part of our students' lives. It is becoming more common in all schools for students to have electronic devices and to utilize them for learning. Our focus is teaching students to use cell phones, tablets, laptops, etc. **responsibly**. We have set the **expectations** below for our students' use of personal electronic devices.

Electronic Device Use: Tablet, Net-book or Laptop (personal electronic devices/ laptops are not permitted).

Electronic devices will be stored in the classroom until they are needed as per teacher permission.

Each student will have access to a Chromebook. Students are expected to pick up their chrome books in the morning prior to first period and take them from class to class. Students will not be permitted to leave class to get their Chromebook if they forget to take it in the morning prior to. They will be allowed to get their Chromebook during breaks only.

Electronic Device Use: Cell phone/Smart Phone Use/Smart Watches/Ear Buds

Cell phones are not to be used during class time, for any reason. Cell phones will be placed in the classroom cell phone caddy in each classroom and removed when class is over. **Cell phones may be used before school, after school, during lunch and breaks exclusively. See chart below for activities included in this policy.**

Expectations and Consequences of irresponsible cell phone use:

First Offense/ Violation:

Expectation: A Single verbal warning by classroom teacher or staff and device must be placed in caddy and silenced by the student. A reminder at the beginning of each class period to place cell phones in the classroom phone caddy will count as the single verbal warning. use of a second cell phone while having placed an initial phone in a classroom caddy escalates the situation to level 3.

Consequence: If a student does not comply with directions, phone(s) will be confiscated immediately, and will result in a noon detention. Use of a second cell phone while having placed an initial phone in a classroom caddy escalates the situation to level 3.

Student may collect the phone(s) at the end of the day.

Second Offense/2 Violation:

Expectation: A Single verbal warning by staff and device must be placed in caddy and silenced by the student.

Consequence: Second offense and or use of a second cell phone while having placed an initial phone in a classroom caddy escalates the situation to level 3. Phone will be confiscated immediately and taken to the Superintendent. A second offense will result in a campus cleanup under supervision of facilities staff and coach notification. Device must be picked up by student's parent.

Third Offense/Violation.

Expectation: A Single verbal warning by staff and device must be placed in caddy and silenced by the student.

Consequence: Device(s) is/are taken to the office and given to the superintendent. A third offence will result in a double dose of campus cleanup under supervision of facilities staff, and Coach notification. Device must be picked up by student's parent after a meeting.

Fourth Offense/ Violation

Expectation: A Single verbal warning by staff and device must be placed in caddy and silenced by the student.

Consequence: Device(s) is/are taken to the office and given to the superintendent. Coach will be notified. Device must be picked up by the student's parent after a penalty of \$15.00 is paid. Additional violations will result in the phone being confiscated and returned only after a \$15.00 penalty payment is made to district (each incident).

Student Code of Conduct:

Be Respectful, Responsible, Safe & Kind

The district has authority and control over a student at school during the regular school day, at any school-related activity, regardless of time or location and while being transported in district-provided transportation. Off campus conduct and outside of school time conduct that violates the district's Student Code of Conduct may also be the basis for discipline up to expulsion if it has the potential to disrupt or impact the safe and efficient operation of the school or interfere with the rights of others *or* be in violation of the current sports contract.

Conduct in Extracurricular Activities

Being involved in any extracurricular activity makes you a highly visible representative of our school. Therefore, the behavior of all participants at any time is very important. We expect a high level of conduct, both in school and outside of school time. To ensure that this happens, all participants will sign the ***Spray School District Athletic/Activities Participation Contract*** at the beginning of the season. The contract will be in regards to the general conduct of the participant at all times, not just during school or the activity itself. Failure to abide by this contract will result in revoking of privileges, suspension or expulsion from that activity. Student clubs and performing groups such as the choir, drama and athletic

teams may establish rules of conduct – and consequences for misconduct – that are stricter than those in this handbook. If a violation is also a violation of the Student Code of Conduct, the consequences specified by the district shall apply in addition to any consequences specified by the organization.

Eligibility for Athletic Participation

1. Any student earning a letter grade of D or F in any class will be placed on probation. The student will then have two (2) weeks to improve the grade. Failure to raise the grade to a C or higher at the end of the two weeks will result in the student being ineligible for athletic participation beginning the following day. The ineligibility will last for a minimum of one week, (Tuesday through the following Monday) at which time the grade must be a C or better to become eligible. The progress reports carry over from one grading period to the next and one semester to the next.
2. Parents, including dorm parents, will be notified of any student earning a D or F by email or mail every Monday or parent contact will be made by the teacher or athletic director regarding the grade.
3. Students must be in attendance on the full day of the activity. This includes practices. Exceptions are excused absences (see **Absences** section above). If a student is absent from school Thursday due to an illness, they are not eligible to participate on Friday, unless they have a written note from the parent stating the student is well enough to participate.
4. Any student on the Discipline Ladder Level 2 or above will miss the next scheduled competition. Any student suspended from school may not attend practices, games or any other school sponsored activity on the days of the suspension.
5. Any student who is expelled from school will not attend practices, games or any school sponsored activity during the expulsion period.
6. There will be no mandatory practices on school holidays or on days when school is cancelled due to an emergency.
7. Students will sign an athletic/activity participation contract prior to each season. A copy will be sent home to parents.
8. Students involved in extracurricular activities must pass a drug tests before fall sports and randomly throughout the year and during the extracurricular activity season as per Spray Board Policy JFCIA.

Conduct in General

The Spray School District has the responsibility to provide an education for all its students – to equip each student with the basic skills, understanding and appreciation for living successfully in our society. The area of student conduct is one, which directly affects the total performance of the school. It is an area in which the student, parent or legal guardian and the school share responsibility.

The Spray School Board recognizes that the development of these qualities in its students is a vital part of the educational process. Therefore, in order to develop such qualities, it is necessary for each student and his/her parent or legal guardian to be aware of the rights and responsibilities of a student in the Spray School District.

School rules exist to protect all of us but they especially protect the rights of each student to an education without disruption in a safe environment. By law the district has the authority and control over a student during the regular school day, at any school-related activity regardless of the time or location or while being transported in district provided transportation. Because it must provide a proper climate for learning, the school is concerned with the development of positive attitudes, habits and behavior in its students of self-discipline, responsibility and respect for other people and their property.

***Not all of the rules are in writing as they are based on good citizenship and common sense. Therefore, it is impossible to cover all possibilities and situations.**

Students will be subject to discipline including detention, suspension, expulsion, denial and/or loss of awards and privileges and/or referral to law enforcement officials for the following, including but not limited to:

1. Assault;
2. Hazing, harassment, intimidation, bullying, menacing or teen dating violence, as prohibited by Board policy JFCF – Hazing/Harassment/Intimidation/Bullying/Menacing/Cyberbullying/Teen Dating Violence/Domestic Violence - Student, and accompanying administrative regulation;
3. Coercion;
4. Violent behavior or threats of violence or harm;
5. Disorderly conduct, false threats and other activity causing disruption of the school environment;
6. Bringing, possessing, concealing or using a weapon as prohibited by Board policy JFCJ - Weapons

in the Schools;

7. Vandalism, malicious mischief and theft, as prohibited by Board policies ECAB - Vandalism/Malicious Mischief/Theft and JFCB - Care of District Property by Students including willful damage or injury to district property; or to private property on district premises or at district-sponsored activities;
8. Sexual harassment;
9. Use of tobacco**, alcohol** or drugs**, including drug paraphernalia;
10. Use or display of profane or obscene language;
11. Disruption of the school environment;
12. Open defiance of a teacher's authority, including persistent failure to comply with the lawful directions of teachers or school officials;
13. Violation of district transportation rules;
14. Violation of law, Board policy, administrative regulation, school or classroom rules.

Note: Students below grade 5 will not be suspended out of school except for Weapon Violations.

Weapons in the School

Under state and federal law, expulsion from school is required for a period of not less than one year for any student who is determined to have brought, possessed, concealed or used a firearm on school property or at a school sponsored activity. The superintendent may modify the expulsion requirement for a student on a case-by-case basis. Additionally, in accordance with Oregon law, any person who intentionally possesses a firearm, unless the person possesses a valid license under ORS 166.291 and 166.292, or other dangerous weapon in or on district property or recklessly discharges a firearm in school is subject to criminal prosecution, a maximum five years' imprisonment, a fine and forfeiture of firearm and/or other dangerous weapon or both. Any person 13 to 17 years of age convicted of intentionally possessing a firearm in a public building is subject to denial of driving privileges for 90 days.

** In accordance with Oregon law, any person under age 18 possessing a tobacco product or an inhalant delivery system commits a Class D violation and is subject to a court-imposed fine, as provided by ORS 167.400. Any person who distributes, sells or allows to be sold, a tobacco product in any form, or a tobacco-burning device or an inhalant delivery system, to a person under 18 years of age commits a Class A violation and is subject to a fine, as provided by ORS 163.575. An unlawful drug is any drug not

prescribed by a licensed medical practitioner. Unlawful delivery of a controlled substance to a student or minor within 1,000 feet of district property is a Class A felony, as provided by ORS 475.999.

“Dangerous weapon” is defined by Oregon law as any weapon, device, instrument, material or substance which, under the circumstance in which it is used, attempted to be used or threatened to be used, is readily capable of causing death or serious physical injury. “Deadly weapon” is defined as any instrument, article or substance specifically designed for and presently capable of causing death or serious physical injury. “Firearm” is defined by federal law as any weapon (including a starter gun) which will or is designed to or may readily be converted to expel a projectile by the action of an explosive. This includes the frame or receiver of any such weapon or firearm, muffler or silencer, or any destructive device.

“Destructive device” is defined as any explosive, incendiary or poison gas component or any combination of parts either designed or intended for use in converting any device into a destructive device or from which a destructive device may be readily assembled. A destructive device does not include any device which is designed primarily or redesigned primarily for use as a signaling, pyrotechnic, line-throwing, safety or similar device. In accordance with the federal Gun-Free School Zone Act, possession or discharge of a firearm in a school zone is prohibited. A “school zone” as defined by federal law means, in or on school grounds or within 1,000 feet of school grounds.

Conduct and Discipline Procedures

Discipline Referrals

- Discipline Referrals are given for serious and/or repeated offenses. They place students on the Discipline Ladder. Staff members will try at least three times to reach the parent by phone within 24 hours. Messages left on a parent’s phone will serve as a direct contact. If direct contact has not been made (the parent did not respond or was unavailable) the student must obtain parent signature on their copy of the Referral and return it to the office.
- For Discipline Referrals: Staff members issuing the Referral/Citation will fill out the form completely, indicating the time at which the offense occurred, the location, check the appropriate box as to the nature of the offense and give a brief description of what occurred.
- Offenses listed with an asterisk on the Discipline Referrals are ones that will result in Out of School Suspension (OSS) or Expulsion.
- When students report to detention they are required to complete a writing assignment and fill out a Plan for Success (PFS) in a sincere manner. They take the PFS to the person who issued it, discuss it with them and obtain the issuing person’s signature. It is up to the staff member to

“problem solve”, sign the student’s PFS and to resolve the incident in order to reestablish a good working relationship with the student in a timely, constructive manner. Students are allowed to attend all their classes.

- Students spend lunch or after school in a detention area and can be assigned an on-campus task.
- Students in grades 4-12 will not be allowed to participate in the next scheduled sport competition or school activity at step two (2) or above on the Discipline Ladder.
- Teachers may supply work for students to make up. They may do make-up work during the time they are in office after completing their Plan for Success and/or campus task.

The Discipline Ladder at SSD is a tool that is used to monitor student behavior. The ladder shows what specific consequence will occur when a student receives a citation for violating a school rule.

The Discipline Ladder allows students to move in two directions. Students move up one step on the ladder with each Discipline Referral (DR) they receive. A student moves down the ladder one step by going eight weeks (32 school days in attendance) without a DR.

Interventions are indicated in parenthesis. Interventions at levels three, five and eight are an indication that those things will happen at that level or before. A possible intervention might include the student being put on a Point Sheet. Interventions will not necessarily happen multiple times as the student moves up and down the ladder.

NOTE: Conduct violations that result in immediate suspensions may move the student to a higher level on the Discipline Ladder at the discretion of administration. For example: a fight will move someone automatically from a level zero to level four. Suspensions may be in or out of school as determined by the Administrator.

The following activities have a negative impact on the atmosphere of the school and may bring the following consequences:

*In addition, when a student commits theft, drug, alcohol and/or tobacco related offenses or any other criminal act, he/she may also be referred to law enforcement officials. If the student is involved in the extracurricular activity program, there will be consequences there as well.

Public Display of Affection

No excessive displays of physical affection are allowed on campus. We are using this years “catch and release” policy for students. This means a brief hug is ok. Laying, lounging or holding together for long periods for sustained amounts of time, is not ok. These things are not inherently bad but are inappropriate for the context of education and school.

Minor (Child) Photo Release Authorization
