Mr. Rolland recommended that the Board approve changing the contract of Robin O'Connor from a full time paraprofessional to 3/8 teacher and 5/8 paraprofessional for the 2024-2025

school year. Nikki King moved to approve the recommendation, Lori Huggins seconded. Motion carried 4-0 (6:31 p.m.).

Mr. Rolland recommended hiring Phyllis Barker and Haylee Eads to positions in the daycare. Mark Flint moved to approve the recommendation, Lori Huggins seconded. Motion carried 4-0 (6:31 p.m.).

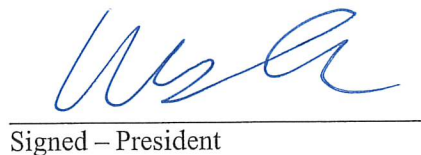
Substitutes
