

Northampton County Public Schools is accepting applications for enrollment in its Universal and Preschool Initiative Programs located at both Occohannock and Kiptopeke Elementary Schools. The following criteria should be considered before completing the application for enrollment:

- Your child must be four years old by September 30, 2024 (No exceptions)
- You must live within the boundaries of the Northampton County Public Schools attendance zone.
- You must be available to put your child on the bus and pick him or her up from the bus daily.
- You must comply with attendance guidelines outlined for all county students.
- An up-to-date physical and a record of immunization must be provided.
- Proof of 911, child's birth certificate and verification of income must be provided.
- Participation in parent workshops before school starts is encouraged.
