If the surveys provide data that professional development is needed for any of the approved uses of the funds this will be addressed during the 2021-22, 2022-23 fiscal years.

Tier 2 students (K-8) will have the option of attending a summer school program over the next several years using the one time ESSER funds provided. All students at the elementary, middle and high school levels will have opportunities to be involved in other summer programming as well as tutoring and intervention during the school year to help reduce the learning gap due to Covid-19.
