### CONSIDERATION OF OUT OF DISTRICT 4TH GRADER:

Sheri Modderman advises that at the beginning of the year, they were expecting about 25 students in the  $4^{th}$  grade but the class is now down to 21. Gary Anderson made a motion to accept the out-of-district student. Mickale Carter seconded the motion. All were in favor. Motion passed.

#### CONSIDERATION OF OPENING TITLE/PE POSITION:

The current PE/Title I teacher is retiring at the end of the school year and the position will need to be filled. Mickale Carter made a motion to open a teaching position. Jeremy Grady seconded the motion. Aller were in favor. Motion passed.

#### CONSIDERATION OF SUPERINTENDENT'S ANNUAL REVIEW AND CONTRACT:

Gary Anderson made a motion to offer a 3-year contract to the Superintendent that includes a \$12,000 salary increase for the first year to bring the Superintendent's salary to \$84,000 per year. The contract should have a provision to increase the insurance stipend if the board approves. The second- and third-year's salary will be evaluated individually for their increase. Jeremy Grady seconded the motion.

Mickale Carter made a motion to amend the salary to \$85,000 for the first year the rest of the terms remain the same. Jeremy Grady seconded the motion. All were in favor. The motion passed.

#### CONSIDERATION OF CLERK'S ANNUAL REVIEW FORM AND JOB DESCRIPTION:

The board reviewed several documents that could represent the duties of the clerk and made suggestions to consolidate the applicable duties and evaluation questions. The document will be moved to a second reading.
