A. Superintendent Announcements – Grey Burton

We learned earlier this month that Nacogdoches ISD has been named a Texas Art Education Association District of Distinction once again, one of 109 school districts around Texas to receive the Visual Arts Award for the 2024-25 academic year. The Visual Art Administrators of Texas, a division of TAEA, recognizes school districts with outstanding leadership in promoting the arts in their district and community. I know our high school art students produce some outstanding work – we've had a number of students recognized over the years – and that's a reflection of the work of our staff and the commitment the district has made to its fine arts program. The creativity that's recognized at the high school level is nurtured from the earliest grades. NISD's visual arts program met or exceeded a rigorous 14-point rubric administered by TAEA. The rubric looks closely at the district's visual art program from participation in TAEA through membership, exhibitions, contests and community engagement in the visual arts through field experiences, community service, and collaboration with other content areas.

While I don't want to alarm anyone, the start of the new school year is here. Classes begin Aug. 13 (that's three weeks from yesterday!) and we will have teachers back next Friday, Aug. 1. Understandably, there are a number of events happening in the district in the coming weeks, including Convocation on Friday, August 8, to kick off the new year.
