## 10. Superintendent's Report

- a. The Transportation Audit District was in compliance. Kristi Hopper made a motion to accept the transportation audit report. Kristain Dedmon seconded the motion. Motion passed 6-0
- b. Policy Updates. Kristian Dedmon made a motion to accept the policies presented with the exception of policy 3.17 and 3.48 until they receive more clarification on those two policies. Denise Williams seconded the motion. Motion passed 6-0
- c. Update on HVAC. Currently in phase 3, they are currently working at the High School they are going to be waiting until summer to get the new units in.
- d. Cafeteria Update at OMS. Should be opened by the new School year. This construction is being covered by ESSER funds
- e. Safety Grant. We have received a safety grant for \$124,000.00. We will be working with school safety officers. Looked into adding screen prints and bumper blockers at CSE. Fire panels have not been communicating with the fire department, but will replace those at North, OMS, and ALE; also getting weapon detection software. Ollie Collins asked about considering an SRO at every campus, Dr. Green said he would look into this. Kristian Dedmon made a motion to accept the safety grant. Ollie Collins seconded the motion. Motion passed 6-0
- f. Summer Learning Camps. We will run a summer camp for 12 days. June 7-8, June 12-15, June 19-22, June 26-27. Will run from 8am 12pm for grades K-12.
- g. Purchase of SPED Bus. Mrs. Gavin would like to get a large passenger bus that is wheelchair accessible. The cost of the bus is \$146,553.00. If approved the bus will be here in the fall. We would own this bus. Denise Williams made a motion to purchase the SPED Bus. Ollie Collins seconded the motion. Motion passed 6-0
- h. Salary Schedule. Dr. Green discussed a salary schedule for certified staff. Every certified teacher, or anyone who teaches a class has to have a base salary of \$50,000.00 anyone making over \$50,000 gets a \$2,000 raise. We would like to offer experience stipends, higher education stipends with a current Arkansas Educator License, and next year offering performance stipends. Mrs. Tippy discussed the Administrator Salary Index.
