There was one guest in attendance to address the board, Mrs. Patricia Compton. Chairman Pierce explained that she would have five minutes to address the board and that Dustin Prichard would be the official timekeeper and would let her know when one minute remained.

Mrs. Compton said she is on the Leadership Committee at McMinn High School, and after speaking with numerous students, parents, and faculty members, she felt there were a few issues that needed to be addressed with the board.
