V. Requested Services

The vendor providing the removal and disposal of current dishwasher and replacement/installation of new dishwasher must bid this as a prevailing wage job. Prevailing wage laws as set will govern all wages paid under this contract forth and by the Division of Labor Standards, Department of Labor, State of Missouri. It is the intent of the school district

that these laws are strictly observed. All contractors performing work on the project will be required to sign and notarize an Affidavit of Compliance with Prevailing Wage Laws.
