

Welcome to 21st Century Schools

The Tazewell County Health
Department, in cooperation with District
108 schools, is proud to offer the
Extended Day program. This before and
after school program is housed on-site at
each primary and intermediate school
within the district. The program is
administered by the Tazewell County
Health Department's Community Health
Division.

The Community Health Division's 21st Century Schools program provides before and after school services in several schools throughout the county. Program components focus on academics, life skills education, parental involvement, service learning, positive adult mentors, physical fitness and cultural activities. The program at each site is administered by 21st Century Schools staff which consists of a Site Coordinator and support staff.

Extended Day Information:

This structured child care program is open to all students enrolled and attending a participating District 108 school. The program is offered mornings and afternoons each day that school is in session. The daily program includes breakfast and an afternoon snack.

Programming may include small group academic activities, quiet time, crafts, physical activity and supervised play.

The Extended Day program operates on a pre-arranged basis. In order to provide adequate supervision, food, and supplies parents must complete a weekly attendance schedule and pay for services in advance.

Each Friday, payment and schedule of attendance are due for the following week. Rates are \$8.00 for morning session and \$12.00 for the afternoon session.



Early Dismissal/Conference Days:

On Early Dismissal days, students may stay after school and enjoy special planned activities. The afternoon rate for early dismissal days is \$20.00 with snack included. Full day services may be available on no school days if the minimum attendance requirement is met. The full day rate is \$30. Registration flyers for full days will be sent home with students throughout the year.

Enrollment Information:

Parents must enroll their child each school year by completing the registration forms located in the Parent Handbook. Parent Handbooks can be obtained from the Site Coordinator, at the school office, or at www.tazewellhealth.org. Students will not be enrolled in the Extended Day program until all required registration paperwork is submitted. Parents will receive a confirmation via email upon your child being enrolled in the program.
