Recommendations to be brought before Board of Trustees

Implementation of Fentanyl-Related Legislation

October is Fentanyl Poisoning Awareness Month

The appropriate grade level recommendation for instruction is 6th-12th grade. Instruction will cover dangers of opioids, including addiction to and abuse of synthetic opioids such as Fentanyl.

We will have a week in October designated as Fentanyl Awareness Week where students are educated about the dangers posed by the drug Fentanyl and the risks of Fentanyl poisoning, including overdose.

Announcements will be made at school, posters will be made and placed in hallways by the student council and the school nurse will make daily social media posts.

This will occur annually in October.

Fentanyl Instruction will Include:

- Suicide Prevention
- Prevention of the abuse of and addiction to Fentanyl
- Awareness of local school and community resources and any processes involved in accessing those resources
- Health education that includes information about substance use and abuse, including youth substance use and abuse

The instruction may be provided by a public or private institution of higher education, library, community service organization, religious organization, local public health agency, or organization that employs mental health professionals or an employee or agent of these entities.
