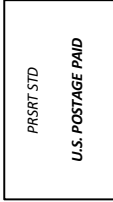


PROPOSITION

Shall the Board of Education of North Summit School District, Utah, be authorized to issue General Obligation Bonds in a principal amount not to exceed \$121,000,000 for the purpose of paying all or a portion of the costs to acquiring, constructing, furnishing and equipping new school facilities; improving or rebuilding existing facilities; and the authorization and the issuance of the Bonds due and payable with a term not to exceed twenty-one (21) years from the date or dates of issuance of the Bonds?



PROPERTY TAX COST FOR THE BONDS

If the Bonds are issued as planned, an annual property tax to pay debt service on the Bonds will be required over a period of twenty (20) years in the estimated amount of \$887.71 on a \$722,055 (average value of residence in district) residence and in the estimated amount of \$ 1614.01 on a business property having the same value.

The foregoing information is only an estimate and is not a limit on the amount of taxes that the district may be required to levy to pay debt service on the Bonds.

The district is obligated to levy taxes to the extend provided by law in order to pay the Bonds.

A new high school would be constructed on the district-owned property southwest of the Coalville Cemetery (construction expected to begin in the Spring of 2026).

- The new high school would have a 640-student capacity, with the ability to expand to meet future needs the site is large enough to accommodate:*
- The new high school and space for growth*
- A competition and auxiliary gym*
- A new auditorium*
- A new football stadium with 8-lane track, practice field, baseball diamond, softball diamond and outdoor courts*
- Ample parking for the school and events*

The existing high school would be demolished, and a new indoor pool would be built in the location of the existing high school. Space for future recreation would be preserved on this site to meet community needs. (construction expected to begin in the fall of 2028).

The Need

North Summit High: *The building opened in the fall of 1977 with the first class graduating in 1978. The building has many failing systems making it necessary to replace. Building a new school at a different location will allow school to continue without disruptions while the new school is built. The new school will be able to provide the students with better technology, safety and more energy efficiency.*

North Summit Swimming Pool: *The pool was originally constructed in 1966. While the pool has been well-maintained, the structure is well over 50 years old, far beyond the anticipated lifespan of an aluminum pool. The pool is not regulation size to for high schools’ standards. Spectator seating is insufficient to meet the needs of the community. Many elements of the current pool and supporting systems are no longer code- compliant*



With the bond funds, the district plans to begin construction on the new North Summit High School in the Spring of 2026. Once completed the old high school will be demolished making room to build a new indoor swimming pool to replace the outdated and decaying pool we currently have.

North Summit School District has been very efficient and conscious of taxpayer’s dollars. The School District has paid off its previous General Obligation Bond in the 2024 Fiscal Year. The school district owns the land where the new school is to be built. General obligation bonds are the most effective method for the proposed projects.

The saying goes that the best time to build was five years ago. The next best time to build is now. Construction projects are nearly 50% more expensive than they were 4 years ago. The district feels that delaying needed projects could increase the cost to residents by millions each year they delay.
