- 2. Motion that the Board of Education, upon the recommendation of Mr. Rose Superintendent of Schools, approves the following resolution:

WHEREAS, New York General Municipal Law, Article 5-G, Section 1119-0 (Section ``9-0) empowers municipal corporations [defined in Article 5G, Section 119-n to include school districts, boards of cooperative educational services, counties, cities, towns and villages, and districts] to enter into, amend, cancel and terminate agreements for the performance among themselves (or one for the other) of their respective functions, powers, and duties on a cooperative or contract basis;

WHEREAS, the Brasher Falls Central School District wishes to invest portions of its available investment funds in cooperation with other corporations and/or districts pursuant to the NYCLASS Municipal Cooperation Agreement Amended and Restated as of March 28, 2019;

WHEREAS the Brasher Falls Central School District wishes to satisfy the safety and liquidity needs of their funds;

NOW, therefore, it is hereby resolved as follows:

That Cynthia Fraser, Treasurer of Brasher Falls Central School District, is hereby authorized to participate in the NYCLASS program under the terms of the NYCLASS Municipal Cooperation Agreement Amended and Restated as of March 28, 2019.
