REQUEST FOR RECONSIDERATION OF MATERIALS

Process:

- 1. Send an objection form in writing to the principal identifying the material(s) and state the basis for the objection.
- 2. The principal has 15 calendar days to review the objection and meet with the objector.
- 3. If the objection is not resolved, the principal shall refer the matter to the Director of Curriculum and Instruction.
- 4. The Director of Curriculum and Instruction shall meet with the objector within 15 calendar days to resolve the objection.
- 5. If the objection is not resolved, the matter will be referred to the School Board for a public hearing within 45 calendar days.

This form must be used by a parent or resident of this county, in conjunction with district policies and procedures, to submit an objection to the school board for the following material:

- 1. Materials used in a classroom in the district, except for instructional materials as defined in s. 1006.29(2), F.S. The process and forms to object to instructional materials can be found at https://www.martinschools.org/.
- 2. Materials made available to students in a school or classroom library.
- 3. Materials included on a school or classroom reading list.
- 4. Instructional Materials adopted and made available to students without the opportunity for public notice, review and hearing procedures by districts that implement their own instructional materials program under s. 1006.283, F.S. (Districts that do not implement their own instructional materials program under s. 1006.283, F.S., must remove item 4.)
