

**Camino Real Middle School

Student Success Agreement**

1. I will adhere to all campus rules and will be a positive role-model student!
2. I will adhere to the school/district dress code and come to school appropriately dressed each day without disruptions to the educational environment.
3. **I will be respectful towards my peers and all staff members. I will address them with kindness and will commit to not using inappropriate language.**
4. All electronic devices are restricted from school. I will leave my cell phone, smart watch, ear buds, and any electronic devices turned off and, in my backpack, when I enter the building. Cell phones are only permitted after school to call parents, otherwise restricted.
5. I will use school district technology appropriately as described in District Policy. This includes taking care of the school issued device, not visiting inappropriate websites, keeping off social media platforms (unless school approved), not participating in cyber-bullying, and keeping out of other student assigned devices/accounts. I am held accountable to the repair costs, replacements and discipline for these actions.
6. I will not ask to leave class excessively so that I don't interrupt my learning. I will not go to the nurse's office unless of an emergency, or through prior approved medical accommodations.
7. I will participate in all my classes and will not distract other students from learning.
8. I will be in school every day unless I have a family emergency or if I'm ill, as described in District Attendance Policy. I will provide a note from parent or doctor for the absence.
9. I will work hard every day and complete my assignments. I am responsible for connecting with my teachers and asking for any work that I am missing because of an absence. I will ask questions in class and will let my teacher know if I am struggling. If I am struggling, I will utilize additional resources available to help me improve.
10. I will respect school property, neighboring establishments including Morning Star Church, State Farm, and resident homes. Any student involved in vandalism – such as tampering with water fountains, writing on bathroom walls, clogging toilets, or defacing any of the above – mentioned properties – will be held accountable. This includes financial restitution for repair costs and the assignment of community service as a part of the consequences.
11. I will always keep my hands to myself, and will not horseplay with friends, instigate fights between friends, or involve myself in any type of unsafe situation which creates violence on the campus.
12. I will not use social media of any kind as a venue to create negativity toward Camino Real Middle School. This includes name calling, threats, spreading rumors, creation of false platform profiles, group chats, or posting inappropriate conduct such as photos or videos of other students.
13. I will not bully students, and if I have knowledge of bullying, I will report it to the front office or to the nearest adult.
14. I will not come to school/participate with any legal or illegal substance that puts me under the influence of alcohol or drugs. I will not bring these substances to the campus in accordance with District Policy. I will report other students, if I witness this on campus.
15. I will not bring any nicotine-based products to campus, and I will not participate in the use of these substances or devices. I will report other students, if I witness this on campus.
16. I will not bring any weapons to campus to include knives, guns, toy guns, or look-alike products of any kind.
17. I understand that I can be subject to a search at any time if there is reasonable suspicion of district policy violation.
18. I understand that I can be held accountable within different levels of discipline for violations of District Policy (community service; lunch detention; restorative reflection; in-school suspension; loss of grade-level incentives throughout the school year; out-of-school suspension; referrals to community intervention programs; police authority involvement; alternative education placement; long-term suspension)
