

# Pulaski County High School Hall Of Fame

## Nomination Criteria 2024

The purpose of the Pulaski County Hall of Fame is to recognize Pulaski County High School graduates, employees, and lifetime contributors who have distinguished themselves by their individual contributions in scholarship, athletics, career, community service, and/or society as a whole. The permanent honor of being elected to the PCHS Hall of Fame will represent individuals who, through their individual actions, have contributed to the established vision of Pulaski County Public Schools.

The categories and criteria for nomination to the Pulaski County High School Hall of Fame were developed as a result of input from the Hall of Fame Committee and citizens of Pulaski County. The final list of categories and criteria reflects the common characteristics of our existing hall of fame and the wishes of the general committee as expressed in preliminary meetings.

Selected Hall of Fame members will continue to serve as a positive role models providing inspiration, hope, support and relevance to our current students as they progress through their own areas of study, athletics, extracurricular activities, or community service.

The submission of a name for consideration will be made in one of six categories. The nomination at the end of this document. Nominees in these categories must have demonstrated high levels of achievement, award recognition and significant contributions in their fields.

1. Medicine and Science – graduates who are surgeons, specialists, and/or general practitioners of high regard or distinction; scientists whose findings have benefited humanity in an important area of existence or who have added substantially to the body of human knowledge; recipients of distinguished awards in any field of scientific endeavor; etc.

2. Business and Professional – graduates who are respected economists, influential stock market analysts, CEOs of noted corporations or businesses, particularly successful business persons, legal professionals, etc.

3. Arts and Entertainment – graduates who are well-known or frequently published writers, winners of prestigious literary, acting or artistic awards; influential critics; recognized musicians or composers; media celebrities; etc.

4. Humanitarian and Service – graduates who have rendered consistent and significant service to the local, state, national or world communities.

5. Athletics – graduates who have competed at the collegiate level, Olympians, or professional athletes; renowned or especially successful coaches, sports specialists, sports promoters; etc.

6. Lifetime Recognition/Contributors – This category is reserved for an individual who has excelled and attained award status in his or her chosen field, promoted Pulaski County High School through their accomplishments, and whose life demonstrates high moral character and dignity.

Once a candidate is nominated in a category, he or she will be evaluated using the following criteria:

1. Exemplary achievements and recognition in their chosen field.
2. Outstanding citizenship.
3. Exhibit qualities of leadership.
4. Has made a meritorious contribution to society.
5. The candidate must demonstrate the qualities listed above in a manner that will inspire the students of Pulaski County High School in the pursuit of excellence.

Community members, alumni, current and former staff members will submit completed nomination forms to the Pulaski County High School Hall of Fame Committee by the published deadline.
