NEW BUSINESS

- 1. ESSER Federal Funds Review Report: We did have a few issues with procurement that we are working through resolution. One thing that was surprising was that we need to put something like textbooks out for bid. We learned in the process that we need to have a specific letter indicating the exception so we need to fix the things that are found moving forward. We have discussed putting a procurement process in place and we are also looking at having some local templates in place to make sure that we are following the correct procedures moving forward.
- 2. Adjustment to SLCS extended school year calendar: Some of the feedback we are getting from staff that leaves is in regard to the extended school year in terms of number of days and extended school day is an issue for the employee. We are considering reducing the school year by 5 days. We do need to then reconsider the holidays. We think it is important to get feedback from some of our families and staff as we are not sure where to possible remove those 5 days from the calendar. We will be putting out a survey in January to see how it comes back and discuss with the board. We will put out a calendar based on those recommendations in March.
