INSTRUCTIONS FOR BIDDING

1. Bids must be written or typed on the Invitation to Bid (or its attachments).
2. Mail or hand deliver sealed bid to the address on the Invitation to Bid.
3. Mark outside of the sealed envelope, the number of this bid: Bid# 02061972. Any bid that is prematurely opened because it is not clearly marked on the outside of the envelope in this manner will be disqualified.
4. Bids must be in the office by the date and time shown on the Invitation to Bid. Late bids WILL NOT be accepted.
5. Bids will be received until the date and hour set in the Invitation to Bid.

2. Awards will be made on the whole.
3. The Board reserves the right to reject any or all bids, in whole or in part, and may waive any formalities in the bid if, in its opinion, it is in the Board's best interest to do so.
4. **Bid Requirements/ Scope of Service:**
 - a. Price must include materials and labor to resurface the floors, paint the walls, and fix any damaged area in student restrooms.
 - b. Floors will need to maintain existing floor drains.
 - c. Walls will need to cover from floor to ceiling, including any necessary trim or caulking.
 - d. Price should include final cleaning and sealing.
 - e. Construct the improvements. The location of the existing restrooms
 - f. Determine the feasibility and constructability of the desired restroom improvements.
5. Interested bidders should schedule a visit to Blytheville Schools to measure and inspect restrooms.

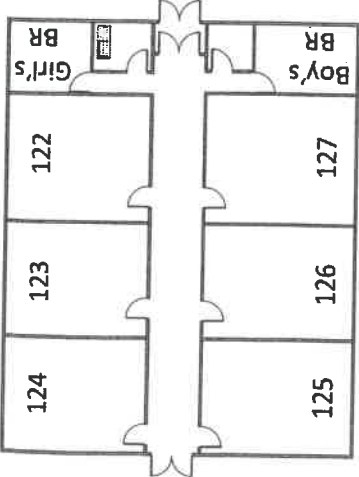
Blytheville Primary



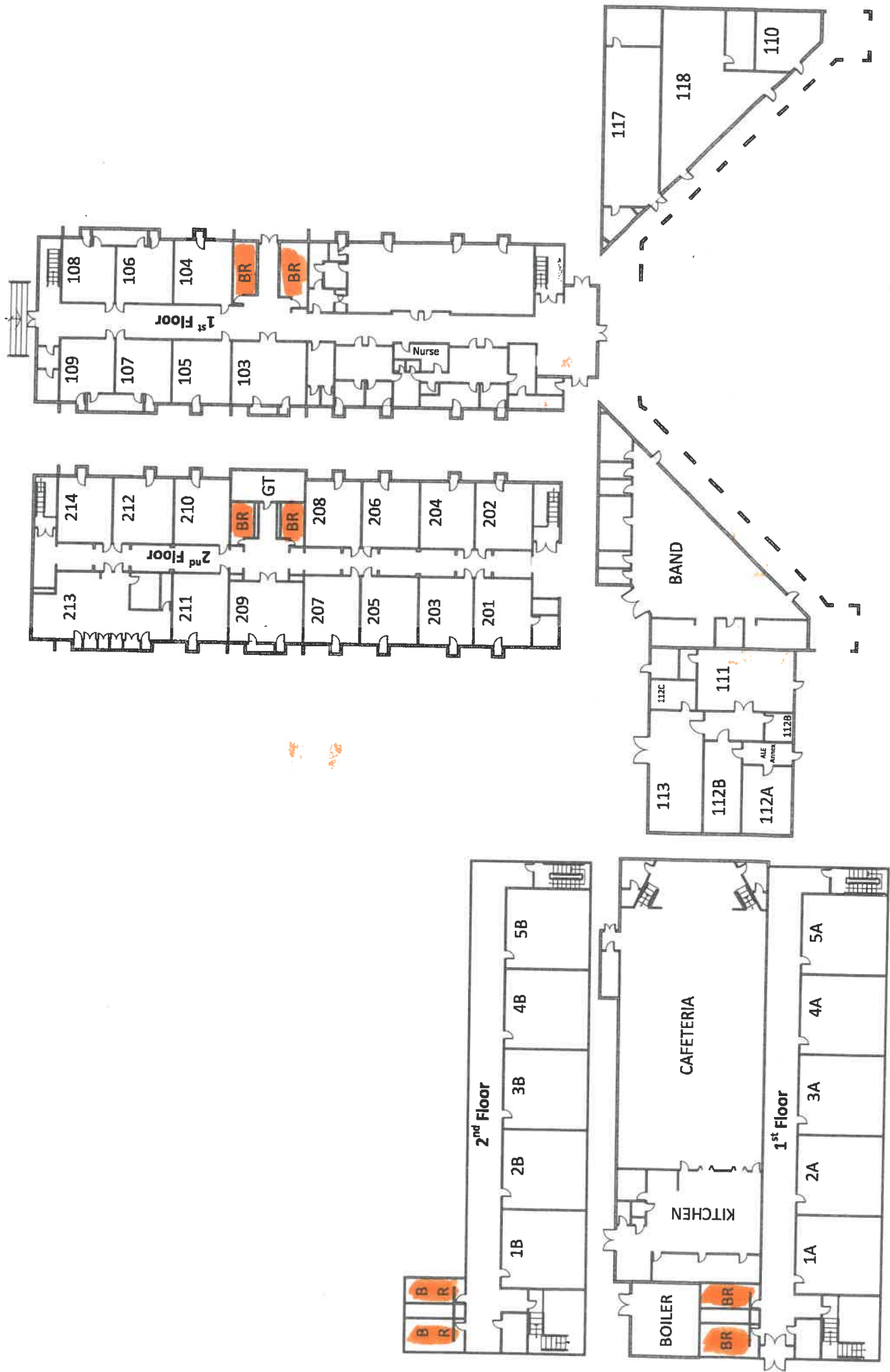
Blytheville Primary - Multi-Purpose:
