The project includes furnishing all labor, material, and equipment and performing all work required to finish the construction of a parking lot at Blytheville Elementary School in Blytheville, Arkansas, as described in the plans and specifications. The project site is located at 216 E. Moultrie Dr, Blytheville, AR.

The project consists of the following:

Furnishing the material, labor, and equipment necessary to finish the parking lot of 16,000 sq. ft. asphalt parking lot with curb and gutter sidewalks and drainage.

- 3. Setup limestone base
- 4. Pave parking lot
