INSTRUCTIONS FOR BIDDING

1. Bids must be written or typed on the Invitation to Bid (or its attachments).
2. Mail, or hand-deliver the sealed bid to the address on the Invitation to Bid.
3. Mark outside of the sealed envelope, the number of this bid: Bid# 03112024. Any bid that is prematurely opened because it is not clearly marked on the outside of the envelope in this manner will be disqualified.
4. Bids must be in the office by the date and time shown on the Invitation to Bid. Late bids WILL NOT be accepted.
5. Bids will be received until the date and hour set in the Invitation to Bid.

3. The Board reserves the right to reject any or all bids, in whole or in part, and may waive any formalities in the bid if, in its opinion, it is in the Board's best interest to do so.
4. **Bid Requirements/ Scope of Service:**
 - a. **Site Preparation:** Clearing and cleaning of the parking lot area.
 - b. **Demolition:** Removal of any existing structures or surfaces as necessary.
 - c. **Grading:** Leveling and grading the parking lot area to ensure proper drainage.
 - d. **Paving:** Installation of new asphalt or concrete surfaces.
 - e. **Striping:** Marking of parking spaces, lanes, and other necessary markings.
 - f. **Signage:** Installation of required signs such as handicapped parking, entrances, exits, etc
 - g. **Project Details.** The Project consists of, but is not limited to, the following: the complete renovation of all onsite access roads and parking areas.

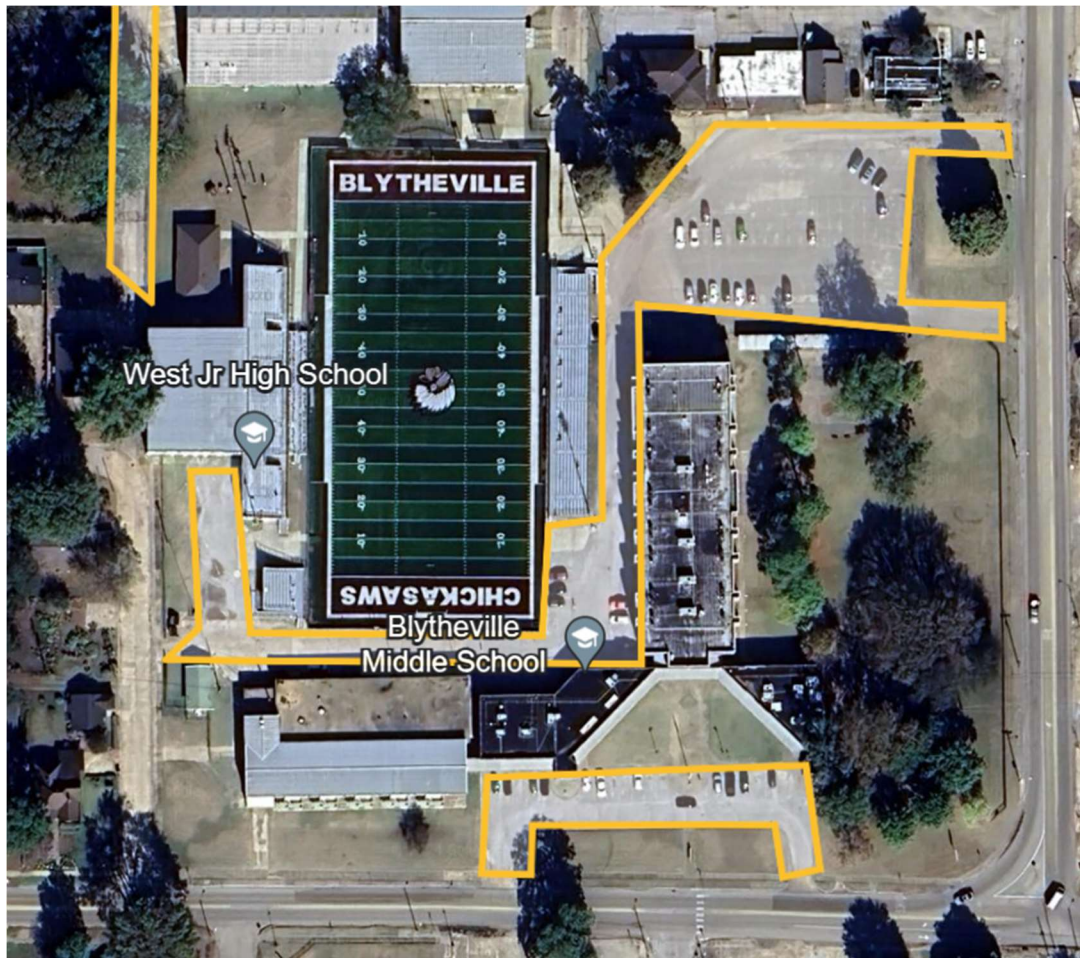
