## **STATEMENT OF PURPOSE**

The mission of the Tulia Independent School District is by moving forward, Tulia ISD will promote leadership, protect learning, and preserve culture every day to maximize the success of every student and staff member in collaboration with our community. A positive link between home and school is vital to the academic success of each child. Tulia ISD is dedicated to developing and maintaining partnerships with parents/guardians and community members by keeping an open line of communication with all stakeholders.

## PARENT/GUARDIAN INVOLVEMENT IN DEVELOPING THE POLICY

The district's Educational Improvement Committee is comprised of parents/guardians, teachers, administrators, and community members. One of the responsibilities of this committee is to address the design, implementation, and review of the district's parental involvement policy.

#### **ANNUAL MEETING FOR TITLE I PARENTS**

Tulia ISD is comprised of three campuses, all of which are Title I, Part A schoolwide campuses. Each campus will hold an annual meeting to review the Title I, Part A services provided for students. For convenience, the meeting may be presented more than once. Some campuses may also choose to post information regarding Title I, Part A on their campus webpage. The Title I, Part A meeting and information are intended to help provide increased coordination and support for both parents/guardians and individual schools resulting in a program tailored to meet the needs of all involved. Copies of the parental involvement policy will be distributed at the meetings. Parents/guardians will be encouraged to assist in revising and updating the policy.

#### SCHOOL-PARENT COMPACTS

In accordance with Title I regulations, each campus has a school-parent compact that outlines the roles and responsibilities of the teacher, parent/guardian, and student in the education of each child. The compact, written in both English and Spanish, is provided annually to all parents, to explain how students, parents/guardians, and staff will share responsibility for student performance and success. Campus Members of the campus advisory committee will be consulted in the design and implementation of the compact. The School-Parent/Guardian Compact will be also evaluated and revised each school year.

A copy of the School-Parent/Guardian Compact can be found on the district and individual campus webpage. In addition, a copy of the School-Parent/Guardian Compact will be provided by all elementary campuses during the Parent/Guardian-Teacher conference held in October. Parents/Guardians may also request to obtain a copy of their student's School-Parent/Guardian Compact at any time. The request can be made to the school's office staff.

#### PÄRENTAL INVOLVEMENT OPPORTUNITIES AND COMMUNICATION

Tulia ISD is committed to assisting each school in planning and implementing effective parent/guardian involvement through technical assistance and coordination of funding to:
