Follett Independent School District hereby gives public notice of its intention to sell the following surplus District tractor:

The PTO (power take-off) is currently inoperable; however, the tractor still runs and the three-point is functional. **THIS ITEM WILL BE SOLD “AS IS,” “WHERE IS,” AND WITHOUT ANY WARRANTY.** By submitting a bid, bidder acknowledges and agrees that if his/her bid is selected, bidder shall bear all risk as to the fitness and condition of the tractor and that the District has expressly disclaimed any and all warranties.

Sealed written bids on the form provided by the District should be submitted in an opaque envelope labeled “Follett ISD Kubota Tractor Bid,” and addressed for delivery to Megan Robertson, Superintendent, either by mail to: Follett ISD, P.O. Drawer 28, Follett, Texas 79034 or by hand delivery to: Follett ISD, 205 E. Ivanhoe, Follett, Texas 79034. All sealed written bids must be received by the Follett ISD Superintendent no later than 1:00 p.m. on February 28, 2024. No faxed or electronic bids or late bids will be accepted.

All bids will be opened and read out loud by the Superintendent at 1:00 o’clock on February 29, 2024. All bidders must be capable of tendering, via cash or certified check, the full price bid within three (3) District business days from the time bids are opened. No installment payouts will be considered, and if the selected bidder is not able to tender full payment in a form acceptable to the District at the time payment is due, such bid shall be considered rejected and the next highest bid shall be selected. The selected bidder will be responsible for removing the tractor purchased from Follett ISD property within ten (10) business days of payment. Bidder’s failure to complete the purchase within the time specified, may forfeit the right to purchase any personal property, and the District may proceed to sell the personal property to next best bidder without further notice or opportunity to cure.

Follett ISD reserves the right to accept or reject any and/or all bids, to waive any and/or all technicalities, and accept the bid which will best serve the needs of the District.
