## **RESOLUTION ITEMS:**

Motion by Mrs. Battaglia and seconded by Mrs. Yuhasz to approve the following resolution items as recommended by the superintendent:

- 1. Approve the contract for the Mustang Stadium Field Improvements with Field of Play, 13875 Hall Road, Chardon, Ohio 44024 in the amount of \$1,141,247.92. See Exhibit A
- 2. Authorize the district to appropriate the necessary funds annually to maintain the Mustang Stadium Field Improvements Project after completion.
- 3. Authorize the district to appropriate \$40,000.00 annually for future resurfacing to Fund # 070-9023.
- 4. Approve the use of Grand Valley's Mustang Stadium for all school operations during normal school hours and allow community group usage outside of school hours. Community groups approved, but not exclusive, are: High School Athletic Teams, Middle School Athletic Teams, All School Affiliated Musical Groups, Youth Recreational Football Groups, Youth Recreational Softball Groups, Youth Recreational Baseball

Groups, Youth Recreational Soccer Groups, and Potential Youth Recreational Track and Field Groups.

5. Authorize the Superintendent and Treasurer on behalf of the district to apply for a FIELD **SURFACE GRANT** in the amount of \$250,000.00 from the National Football League Foundation Grassroots Foundation Grant Program through the Local Initiatives Support Corporation for the 2024 grant period cycle for installation of synthetic turf on the district's athletic field (Mustang Stadium Field Improvements).

Field Of Play will provide all materials, labor and equipment necessary to complete the following scope of work at Grand Valley High School Football field (actual field dimensions, turf panel configuration and resulting square footage of purchase and/or amount of material shipped, to be determined). Field Of Play will excavate and laser grade the field areas and install FOP52 Turf on the compacted stone base with a pressure treated anchor system. Markings and logos will be per the final approved drawing.

Commencement of work and shipment of materials shall be in conformance with project specifications and completion of installation shall be per the project schedule agreed to by the parties. Installation will commence following the availability and access to the site by Field Of Play to be determined. Installation will be completed in approximately 180 good weather working day and substantial completion date of August 2, 2024.
