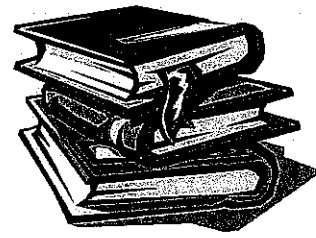


# **Rev. Clifford K. Cliver & Lucy Cliver Sumsky Scholarship**

## **Who is eligible to apply?**

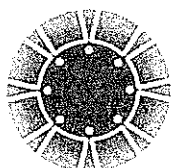
1. Student must have graduated from one of the school districts within Chautauqua County.
2. Student must have been in foster care at some time during his/her life.
3. Student must be 17 years old or older.
4. Student must be continuing his/her education at a university, college, or trade school.

## **Application Process**

1. Interested students will complete the application electronically, attach essay, and send in one email to Counseling/Guidance Department and [scholarships@nccfoundation.org](mailto:scholarships@nccfoundation.org) with the subject title, "Cliver Sumsky Application," by April 1st.
2. Student must meet eligibility requirements.
3. Check will not be sent until all requirements in award letter are completed.

1. Application content.
2. Sincerity of essay.

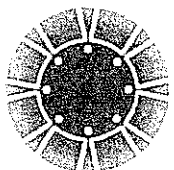

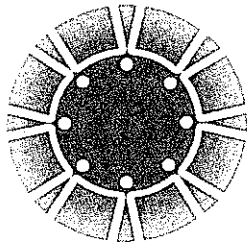
